

Off Licence

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **THIARA LIQUOR LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **161 JELLCOE STREET, TE PUKE** and known as **THIRSTY LIQUOR TE PUKE**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday 9.00am to 10.00pm

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. **A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.**
5. **There is to be no single sales of mainstream beers and RTDs under 500mls and/ or those not designed by the manufacturer to be sold as single serves.**
6. **No light spirits up to 1125ml and up to 13.9% abv are to be sold under this licence.**
7. **All cans of high alcohol (over 6% abv) beverages 500ml or over are to be marked with a number '7' on the bottom of the can. This condition does not apply to craft beer;**
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

(a) either—

(i) until the close of the period for which it was last renewed; or

(ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but

(b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—

(i) until the close of the period of 3 years after the period for which it was last renewed; or

(ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

This licence continues in force until 15 April 2022 unless renewed.

The Application

Thiara Liquor Limited applies for grant of an OFF Licence in respect of premises situated at 161 Jellicoe Street, Te Puke known as "Thirsty Liquor Te Puke."

The application comes about following a sale of the business and this applicant currently trades under a Temporary Authority.

The business is a franchised bottle store and meets the criteria of s.32(1)(b) of the Act in that it is retail premises from which more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else.

The entire premises is designated as a Supervised Area.

The days and hours sought are: **Monday to Sunday 9.00am to 10.00pm**. These hours are within the default national maximum trading hours and the operative Tauranga and Western Bay of Plenty Local Alcohol Policy as it pertains to off-licensed bottle stores.

Building and Planning Certificates have been sought and granted for this activity.



Public Notification:

The application was notified in the Te Puke Times on the 24th of September 2020 and 1 October 2020. No objections from the public were received by the secretariat.

REASONS FOR THE DECISION

Neither the Police, nor the Medical Officer of Health, raise any matters in opposition.

The Inspector reports that the new owners have been operating compliantly under TA and the supervision of the previous owner.

He believes they are unlikely to contribute to the further reduction of the amenity and good order of the area by more than a minor extent.

However, he has impressed upon them the problem with the street drinkers in the Te Puke township who regularly breach of the alcohol ban.

A hearing in 2019 heard that this group of street drinkers appeared to have easy access to alcohol from the town's outlets and were causing significant harm to themselves and others. One member of that group was found dead in a backstreet after a heavy drinking session.

As a result of that hearing the agencies and the Committee have drawn a deep line in the sand for Te Puke. In our decision for **HB Enterprises Limited 22/RENOFF/7445/2019** we said:

90. However, it was pleasing to see the commitment coming forward now from the agencies and the applicant to tackle the issue. Without overstating it, it is sad that it has taken a tragic and foreseeable death, and a renewal of licence, to galvanise the applicant into action.

91. We intend to impose a suite of conditions on the renewal that will steer the applicant in the right direction. We expect them to go door knocking, if they haven't already done so, to the other off-licensed premises in town and asking them to come on board and voluntarily adopt the discretionary conditions we intend to apply on this licence and to become actively involved in the Off-Licence Alcohol Accord.

- 92. Some of the measures may upset some 'good' customers, but we say this, sometimes we all might have to accept a little inconvenience in our lives for the greater good of the community. Alcohol is no ordinary commodity. Selling and supplying alcohol comes with serious responsibilities. It is not 'just about operating a business.'**
- 93. We are not happy with the prominent position that Kingfisher Strong is displayed in this store. Its current positioning is in a prime location. We would prefer the applicant not to stock this product, or similar items of single serve 500ml high alcohol percentage beverages. If they are to be stocked, they should be placed in a low-profile display area in the store and each can is to have an indelible black line drawn across the bottom of the can prior to being placed on sale.**
- 94. Once the other bottle stores and the supermarkets are on board, they will be required to place 2, 3, 4 or 5 black lines on the bottom of the cans. These will be coded back to the store and if found dumped in the reserve or the CBD will give a clear indicator back to the source store. This information should not be used for punitive action but will indicate where additional resources and measures may need to be directed.**
- 95. However, should sale and supply issues continue to arise from, or in, the vicinity of this premises we would expect to see firm enforcement action undertaken by the agencies. Shoulder-tap purchases by members of the public who buy alcohol for banned people must be dealt with firmly. The agencies can set up a mini-operation and catch a few such purchasers and make an issue about it by charging them with the offence of supplying an intoxicated person and/or trespassing them from the off-licensed accord members premises.**

We are pleased to see that this applicant has embraced the need for additional discretionary conditions, and by consent they will be applied to this licence. For **Thirsty Liquor Te Puke** this means there must be no single serves of mainstream beers or RTDs and if products such as Godfather or Kingfisher Strong are to be sold, that they are to be indelibly marked as discussed above.

Collectively, the off-licensed outlets of Te Puke must step up and restrict the sales of alcohol to the street drinkers and to those that on-supply to them.

On-going decisive action is required by all parties to the equation to bring about a positive change to the CBD of Te Puke township.

Subject to the above, I am satisfied as to the matters to which we must have regard as set out in s.105 and 106 of the Act.

I consider the application on the papers.

DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **grants** an application by **Thiara Liquor Limited** for a new OFF Licence in respect of premises situated at 161 Jellicoe Street, Te Puke known as "**Thirsty Liquor Te Puke,**" subject to conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday 9.00am to 10.00pm

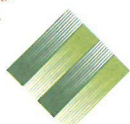
2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. **A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.**
5. **There is to be no single sales of mainstream beers and RTDs under 500mls and/ or those not designed by the manufacturer to be sold as single serves.**
6. **No light spirits up to 1125ml and up to 13.9% abv are to be sold under this licence.**

7. All cans of high alcohol (over 6% abv) beverages 500ml or over are to be marked with a number '7' on the bottom of the can. This condition does not apply to craft beer;
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, and supplied free as a sample for consumption on the premises, only on the following days and hours: **Monday to Sunday 7.00am to 10.00pm**;
2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day;
3. No alcohol may be sold other than –
 - a. beer that complies with the appropriate New Zealand food standard for beer; or
 - b. mead that complies with the appropriate New Zealand food standard for mead; or
 - c. fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - d. grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - e. a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted;
4. While alcohol is being supplied free as a sample, water is to be provided to patrons at no cost from a water supply prominently situated on the premises;
5. A properly appointed Certificated, or Acting or Temporary, Manager must be on duty, at or nearby the point of sale, at all times when the premises are open for the sale and supply of alcohol.
6. **There is to be no single sales of mainstream beers under 500mls and/or those not intended by the manufacturer to be sold as single serves.**
7. **All cans of high alcohol (over 6% abv) beverages 500ml or over are to be marked with a number 4 on the bottom of the can. This condition does not apply to craft beer;**
8. The Licensee must display signage as follows:
 - a. At every point of sale signage detailing the restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance to the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
9. The "single alcohol area" for the premises is as described on the plan dated **19 March 2021** and attached at Appendix 'A' to the licence. The licensee must ensure that:
 - a. No alcohol is displayed, promoted or advertised outside the single alcohol area; and
 - b. No products other than alcohol, low-alcohol and non-alcoholic beer, wine or mead are displayed, promoted or advertised inside the single alcohol area.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- a. until the close of the period for which it was last renewed; or
- b. if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence replaces licence no. 022/OFF/6598/2017 and this licence continues in force until 21 February 2024 unless again renewed.

The Application

This is an application by **Jjach Holdings Limited** for the renewal of the OFF Licence in respect of premises situated at 12 Jocelyn Street, Te Puke, known as "**Te Puke New World.**"

The applicant has been operating this supermarket for 4 years at this site.

The current days and hours are **Monday to Sunday 7.00am to 10.00pm**. No changes are sought.

These are within the default national maximum trading hours for off licences of 7am to 11pm and within the operative Tauranga and Western Bay of Plenty Local Alcohol Policy.

The business is a franchised, open-plan store with shelves and aisles holding food products and other household goods on all sides and a single alcohol area (SAA) in one corner of the store.

The application was notified in the Te Puke Times on the 28th of January and the 4th of February 2021 and no objections were received from members of the public.

Neither the Police, nor the Medical Officer of Health oppose the renewal.

REASONS FOR THE DECISION

The application is complete and contains all the necessary considerations as required under s.127 of the Act. It was duly advertised, and no public objections were received.

We are advised that the perimeter of the Single Alcohol Area remains unchanged and is clearly defined on the new plan dated 19 March 2021. The applicant confirms that no alcoholic product is displayed on the ends of the aisles abutting the perimeter line.

In July 2019 the Committee conducted a public hearing into the renewal of another Te Puke off-licensed premises.

In approving the renewal, we made it clear that collectively, the off-licensed outlets in Te Puke needed to step up and restrict the supply of alcohol to a problem group of hardened street drinkers.

In that decision we applied a number of discretionary conditions to the renewal, and we said:

92. ***Some of the measures may upset some 'good' customers, but we say this, sometimes we all might have to accept a little inconvenience in our lives for the greater good of the community. Alcohol is no ordinary commodity. Selling and supplying alcohol comes with serious responsibilities. It is not 'just about operating a business.'***
93. ***We are not happy with the prominent position that Kingfisher Strong is displayed in this store. Its current positioning is in a prime location. We would prefer the applicant not to stock this product, or similar items of single serve 500ml high alcohol percentage beverages. If they are to be stocked, they should be placed in a low-profile display area in the store, and each can is to have an indelible black line drawn across the bottom of the can prior to being placed on sale.***
94. ***Once the other bottle stores and the supermarkets are on board, they will be required to place 2, 3, 4 or 5 black lines on the bottom of the cans. These will be coded back to the store and if found dumped in the reserve or the CBD it will give a clear***

indicator back to the source store. This information should not be used for punitive action but will indicate where additional resources and measures may need to be directed.

95. ***However, should sale and supply issues continue to arise from, or in, the vicinity of this premises we would expect to see firm enforcement action undertaken by the agencies. Shoulder-tap purchases by members of the public who buy alcohol for banned people must be dealt with firmly. The agencies can set up a mini-operation and catch a few such purchasers and make an issue about it by charging them with the offence of supplying an intoxicated person and/or trespassing them from the off-licensed accord members premises.***

We are pleased to see that this applicant has embraced the need for additional discretionary conditions and by consent they will be applied. For Te Puke New World this means there must be no single serves of mainstream beers and if products such as Godfather or Kingfisher Strong are sold, they are to be indelibly marked as discussed above.

We thank the Inspector for working diligently on this problem in the Te puke township.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 and s.112-115 of the Act.

Accordingly, I deal with the matter on the papers.

DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **Jjach Holdings Limited** for the renewal of an OFF Licence in respect of premises situated at 12 Jocelyn Street, Te Puke, known as "Te Puke New World" subject to conditions.

As a matter of completeness, we grant a waiver for the incorrect hours in the public notices.

We also refresh the licence conditions to reflect best practice and the amendment to the Act permitting non-alcoholic beers to be displayed in the SAA.



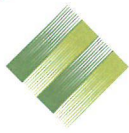

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day;
3. No alcohol may be sold other than –
 - a. beer that complies with the appropriate New Zealand food standard for beer; or
 - b. mead that complies with the appropriate New Zealand food standard for mead; or
 - c. fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - d. grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - e. a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted;
4. While alcohol is being supplied free as a sample, water is to be provided to patrons at no cost from a water supply prominently situated on the premises;
5. A properly appointed Certificated, or Acting or Temporary, Manager must be on duty, at or nearby the point of sale, at all times when the premises are open for the sale and supply of alcohol.
6. **There is to be no single sales of mainstream beers under 500mls and/or those not intended by the manufacturer to be sold as single serves.**
7. **All cans of high alcohol (over 6% abv) beverages 500ml or over are to be marked with a number 4 on the bottom of the can. This condition does not apply to craft beer;**
8. The Licensee must display signage as follows:
 - a. At every point of sale signage detailing the restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance to the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.

9. The “single alcohol area” for the premises is as described on the plan dated **19 March 2021** and attached at Appendix ‘A’ to the licence. The licensee must ensure that:
- a. No alcohol is displayed, promoted or advertised outside the single alcohol area; and
 - b. No products other than alcohol, low-alcohol and non-alcoholic beer, wine or mead are displayed, promoted or advertised inside the single alcohol area.

Section 21 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **TE PUKE UNITED FOOTBALL CLUB INC** (the licensee) is authorised to sell and supply alcohol on the premises situated at **LITT PARK, PARK LANE, TE PUKE** and known as **TE PUKE UNITED FOOTBALL CLUB INCORPORATED** for consumption on the premises, to any person who –

- (a) is a member of the club; or
- (b) is on the premises at the invitation of, and is accompanied by, a member of the club; or
- (c) is a member of some other club with which the holder of the licence has an arrangement for reciprocal visiting rights for members.

The authority conferred by this licence must be exercised through a manager or managers appointed by the club in accordance with subpart 7 of part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

Saturday & Sunday 12.00 noon to 10.00pm
2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
3. **Alcohol can be sold and supplied to guests of members of clubs with which the licensee has an arrangement for reciprocal visiting rights for members;**
4. **While the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.**
5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
6. At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available. Menus must be visible, and food should be actively promoted.
7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by persons using the premises.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

The Application

Te Puke United Football Club Incorporated applies for a renewal and variation of the Club Licence in respect of premises situated at Park Lane, Te Puke.

The general nature of the activity is that of a Football Club and they have 50 registered members,4 of which are under the age of 18 years.

The application was publicly notified in the Te Puke Times on the 11th of March 2021 and no objections were received from members of the public.

The current days and hours are:

Monday to Friday 6.00pm to 10.00pm

Saturday 2.00pm to 10.00pm

Sunday 12 noon to 8.00pm

The Club seek a variation of the days and hours to:

Monday to Friday 6.00pm to 10.00pm

Saturday 12.00 noon to 10.00pm

Sunday 12 noon to 10.00pm

A basic list of substantive food options and low and non-alcoholic beverages are available at all times when the premises is open for the sale and supply of alcohol.

Neither the Police nor the Medical Officer of Health has raised any matters in opposition.

REASONS FOR THE DECISION

The principal activity is a winter time sporting club and the inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent and that the Club has sound host responsibility practices.

The increase in licensed hours are not significant, and are approved, but we remind the Club that the bar hours must be closely aligned to club activities.

The Club also seeks the ability to sell and supply alcohol to bono fide guests of reciprocal members as prescribed in Section 60(1)(b) of the Act.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.120 and s.131 of the Act.

We consider the renewal, with variation, on the papers.

DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **Te Puke United Football Club Incorporated** for a renewal and variation of the Club Licence in respect of premises situated at Park Lane, Te Puke subject to conditions.

We also refresh the licence conditions to reflect best practice and the new provisions in the Act.

Conditions:

The licence is subject to the conditions listed below:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

Monday to Friday 6.00pm to 10.00pm
Saturday & Sunday 12.00 noon to 10.00pm

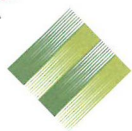
2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.

- (c) The licensee shall have available for consumption on the premises, at all times when alcohol may be sold and supplied under the licence, a reasonable range of non-alcoholic refreshments, low alcoholic beverages (<2.5%) and food specified in the application.
- (d) Information regarding and assistance with alternative forms of transport must be available.
- (e) For the purposes of the licence a **certificated duty manager** must manage the sale and consumption of alcohol, and to ensure the compliance with the provisions of Sale and Supply of Alcohol Act 2012.
- (f) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) Ensure that no intoxicated persons are allowed to enter or to remain on the premises.
 - (ii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of alcohol to minors and intoxicated persons adjacent to every point of sale.
- (g) No BYO permitted.
- (h) The licensed area is designated as supervised.
