

Off Licence Renewal

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **PAENGAROA LIQUOR LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **5 OLD COACH ROAD, PAENGAROA** and known as **PAENGAROA LIQUOR**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises only on the following days and hours:

Monday to Sunday 9.00 am to 9.00 pm.

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day;
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied;
4. The licensed area is designated as Supervised;
5. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
6. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

DURATION

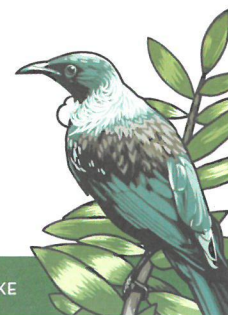
Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

THE APPLICATION

This is an application by **Paengaroa Liquor Limited** for the renewal of an OFF Licence in respect of premises situated at **5 Old Coach Road, Paengaroa**, and known as **Paengaroa Liquor.**

The business is a bottle store where the principal business is the sale of alcohol and meets the criteria of s.32(1)(b) of the Act where more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else. The most recent annual sales figures provided by the applicant indicate that 85% of the annual sales revenue is derived from the sale of alcohol.

The applicant is a limited private company incorporated on 21 April 2006 and has been trading since 26 May 2014. This is the applicant's third renewal application.

The current days and hours of operation are:

Monday to Sunday 9.00 am to 9.00 pm

These hours are within the operative Tauranga and Western Bay of Plenty Local Alcohol Policy as it relates to off-licensed bottle stores.

As the premises is a bottle store where the principal business is selling alcohol, the entire premises is designated as a Supervised Area.

The premises consist of one large rectangular room with a walk-in refrigerated beer chiller at the rear of the premises. Products are situated around the walls and behind the counter. The checkout is situated on the right-hand side as customers enter the store and provides ample coverage of the store and who is entering the premises.

No changes to the existing licence conditions are sought.

PUBLIC NOTIFICATION

The application was publicly notified in the Bay of Plenty Times on the 28th April and 5th May 2021. No objections to the application were received by the secretariat.

REASONS FOR THE DECISION

The Inspector reports that the annual sales figures provided by the applicant indicate that 85.0% of the annual sales revenue is derived from the sale of alcohol. While still within compliance with section 32(1) (b) of the Act that states that at states at least 85% of the sales should be derived



from the sale of alcohol, the applicant will need to be aware that falling below this figure could compromise any future renewal application.

No additional information has come to light to indicate the sale or supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol.

Neither the Police, nor the Medical Officer of Health have raised any matters in opposition to the application,

I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

DECISION

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by **Paengaroa Liquor Limited** for renewal of an Off-licence in respect of premises situated at **5 Old Coach Road, Paengaroa** known as "**Paengaroa Liquor**", subject to conditions.

Conditions

The licence is subject to the conditions listed as follows:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises only on the following days and hours:

Monday to Sunday 9.00 am to 9.00 pm.

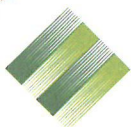

Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **CAFE STRATA 2004 LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **22 WILSON ROAD, WAIHI BEACH** and known as **CAFE STRATA**, to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not present on the premises to dine.
2. Alcohol may only be sold and supplied for consumption on the premises on the following days and during the following hours:

Monday to Sunday: Hours: 9.00 am to 11.00 pm.

3. Free drinking water is to be always available to customers on the tables.
4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol. Menus must be visible and food should be actively promoted.
5. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
6. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
7. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- a. until the close of the period for which it was last renewed; or
- b. if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence replaces licence no. 022/ON/7230/2018 and this licence continues in force until 12 June 2024 unless again renewed.

The Application

This application, submitted by **CAFE STRATA 2004 LIMITED**, seeks a renewal of an **ON LICENCE** in respect of premises situated at **22 WILSON ROAD, WAIHI BEACH**, known as **CAFE STRATA**.

The applicant is a New Zealand private limited company, initially incorporated on 9 August 2004. The business has been trading with an on-licence in its current location since 12 June 2017.

The general nature of the business undertaken is that of an **ON LICENCE - CLASS 3 RESTAURANT**, essentially a café providing all day breakfasts, burgers and cabinet food. It's principal entrance is accessed from a Pedestrianised footpath outside 22 Wilson Road, Waihi Beach in the town centre of Waihi Beach.

The applicant seeks no changes to the licensed days or hours, which currently are Monday to Sunday and Hours: 9.00 am to 11.00 pm.

Nor does the applicant does not seek any changes to the current licence (022/6823/2017).

Therefore the criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

The Reasons for the Decision

The application was publicly notified in the Bay of Plenty Times:

- First Notice 21 May 2021
- Second Notice Not required
- The objection period expired on: 14 June 2021.

There have been no public objections made in the prescribed time scale.

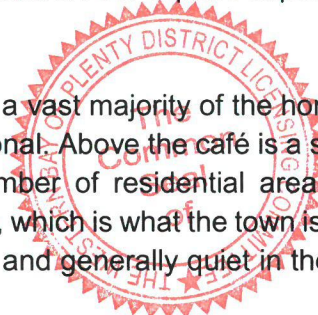
Police reporting on the application on 19 May 2021 reported it does not oppose the application.



The Medical Officer of Health reporting on the application on 10 June 2021 reported it does not oppose the application.

The Inspector does not oppose this application reporting that:

- A general discussion was held with the duty manager on 9 June 2021 during an inspection of the premises and there appears no reason to question the applicant's suitability.
- No information (within the past three years) has come to light regarding the operation of the premises and no concerns have been reported from the agencies regarding the conduct of the premises or the owner.
- There have been no issues raised in respect to the Building Code or the Resource Management Act.
- The premises, situated on the ground floor of a small apartment complex, consists of one large room. The serving counter is at the back of the room as is access to the kitchen. The floor space contains tables and chairs. Outside the front of the café is a small area segregated from the pavement, which also contains seating for customers. Alcohol is kept behind the serving counter. There is no bar; only a serving counter. The licensed area is the entire internal floor area of the premises (where the public have access) and the outside area out the front of the café. The defined area is more precisely identified on the plan date stamped as received by the Western Bay of Plenty Council on 17 May 2021. No information has come to light to indicate there has been any problem with the layout and the management of the consumption of alcohol with respect to the duty manager being able to observe and monitor. Thereby he has no concerns with the design and layout of the premises.
- When visiting the premises on 9 June 2021 all the required signage was clearly displayed. The duty manager's name was prominently displayed. The duty manager was present on the premises and overseeing the licensed area. Low and non-alcoholic beverages were available, as was free water. Food was displayed in the food cabinet and was being prepared in the kitchen. Menus were displayed on the tables and specials on the chalk board. Alternative transportation was in the form of a taxi information on the serving counter. No other goods and services were observed other than food and drink.
- The immediate neighbouring businesses consist of a dairy, a gift store and a Spanish styled café -bar. On the opposite side of the road is an Indian restaurant, a fishing store and a real estate agent. The only other licensed premises in the local vicinity is the Spanish styled cafe, a bottle store, a restaurant and a Four Square supermarket. Further afield is a hotel with an off and on-licence.
- Waihi Beach is heavily populated with housing, but a vast majority of the homes are holiday homes, meaning the area is generally seasonal. Above the café is a series of apartments. Behind Wilson Road there are a number of residential areas. The nearest park is Wilson Park. There is also the beach, which is what the town is named after. The area is very busy in the summer months and generally quiet in the cooler months.



- He is not aware of any issues relating to noise, nuisance or vandalism associated with the cafe in the last three years and there is no information to suggest the premises are associated with criminal behaviour, nor is there visual evidence of anti-social behaviour such as discarded bottles, cans or litter to indicate the parking facilities on Wilson Road are being used to pre-load.
- The café is kept clean and tidy and always has an appealing nature. Taking all this into account there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.
- At present there are two duty managers recorded as working for the premises. Staff training is conducted by John Pepper, the director. The host responsibility policy was displayed. The duty manager's register was kept up to date and it appears appropriate systems, staff, and training comply with the law.

After carrying out due diligence and considering this application, the Inspector reports there is nothing to suggest that the granting of this application would not achieve the object of the Act.

The Local Alcohol Policy stipulates the maximum hours for an On-licence are 9.00am to 1.00am the following day; thereby the hours sought are within the hours permitted under the local alcohol policy.

The Decision

Thereby I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

The Decision

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **approves** the renewal of a Class 3 Licence to **STRATA 2004 LIMITED** trading as Cafe Strata Cafe from 22 Wilson Road, Waihi Beach, subject to the following conditions.

- (a) No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not present on the premises to dine.
- (b) Alcohol may only be sold and supplied for consumption on the premises on the following days and during the following hours:
Monday to Sunday: Hours: 9.00 am to 11.00 pm.
- (c) Free drinking water is to be always available to customers on the tables.

- (d) Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol. Menus must be visible and food should be actively promoted.
- (e) The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;

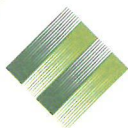

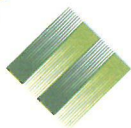

The applicant holds the prescribed Licence Controller Qualification/s and is the director of Thirsty Liquor in Te Puke.

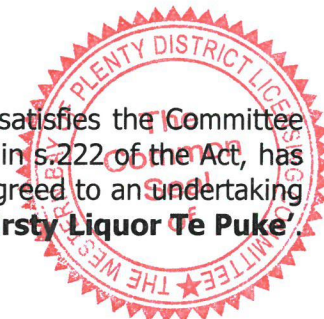

The certificate is granted for a period of twelve months from the date the certificate is issued.

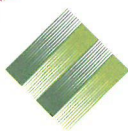

The application and supporting information thereby must satisfy all the matters set out in s.222 of the Act.

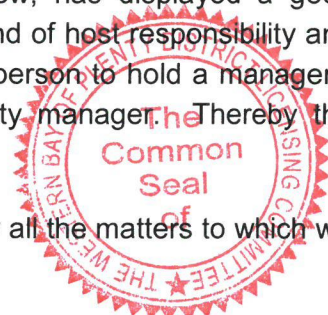
Reasons for the Decision
