Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012 (the **Act**), **ANGELIN ENTERPRISES LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **15C MINDEN ROAD**, **TE PUNA** and known as **TE PUNA WINES & SPIRITS**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours: **Monday to Sunday 10:00am to 10:00pm.**
- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day:
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied;
- 4. The whole of the premises is designated as a Supervised Area;
- 5. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- 6. A properly appointed Certificated, or Acting or Temporary, Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 7. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
  - c. A copy of the licence attached to the inside of the premises so as to be easily read
- 8. No alcohol of the following types are to be sold under this licence:
  - Spirit-based shots of any type;
  - b. Light spirits up to 13.9% abv of any type
  - c. Cask wine of any type;
  - d. No mainstream beers are to be sold under \$25 per dozen
  - e. There must be no floor displays (all alcohol will be on shelves or display plinths/barrels etc);
  - f. All RTDs must be stocked in the chiller;
  - g. There must be no RTD's in the fridges that face onto the retail floor area;
  - h. No specials on RTD's;
  - i. No alcohol brand or price promotions on the exterior of the premises.
  - j. No single sales of RTD's or mainstream beers under \$6.

#### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- a either-
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- b. if an application for the renewal of the licence is duly made before the licence would otherwise expire, either-
  - (i) until the close of the period of 3 years after the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

- 7. The "single alcohol area" for the premises is as described on the plan dated 11 June 2019 and attached at Appendix 'A' to the licence. The licensee must ensure that:
  - a. No alcohol is displayed, promoted, or advertised outside the single alcohol area; and
  - b. No products other than alcohol, low-alcohol and non-alcoholic beer, wine or mead are displayed, promoted, or advertised inside the single alcohol area.

### **THE APPLICATION**

This application, submitted by **JONES RETAIL LIMITED**, seeks a renewal of an **OFF LICENCE** in respect of premises situated at **37–41 MAIN ROAD**, **KATIKATI**, known as **KATIKATI FOUR SQUARE**.

The general nature of the business undertaken is that of an **OFF LICENCE - GROCERY STORE.** Its principal entrance is accessed from car parking off Main Road, Katikati, directly outside the store. Days and hours sought Monday to Sunday 07.00a.m. to 10.00p.m.

The applicant is a limited private company (Incorporation No. 1874820 – 13<sup>th</sup> October 2006) and has been trading since 17 March 2009 with an Off-Licence at its current location. The shareholders are: The Jones Retail Trust, Peter John Jones, and Sandra Frances Jones).

The applicant's current Licence 022/RENOFF/7526/2019 has a 17th March 2022 expiry date.

The applicant being a grocery store and sells a wide range of goods.

The applicant does not seek any changes to the current conditions of the off-licence.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

## **REASON FOR THE DECISION**

A public notice placed in the Bay of Plenty Times on March 3<sup>rd</sup> and 10<sup>th</sup> March, 2022 public objections were submitted.

Neither the Police reporting on the 12<sup>th</sup> May 2022 nor the MoH reporting on the 24<sup>th</sup> March oppose this application

Fire Emergency New Zealand does not oppose this application.

An off-licence may be renewed for this kind of premises because it meets the description found at section 32(1) (f) of the Act.

The Inspector reports the following:

- Annual sales figures for the business indicate that food products are the principal business (49.88%) and alcohol sales account for 18.75% of business.
- From a general discussion held with the duty manager on Thursday 17 February 2022 during an inspection of the premises it appeared the duty manager is aware of the responsibilities under the Act and there is no concerns with the applicant's suitability.
- No adverse information has come to light regarding the operation of the premises over the last renewal period nor that the sale or supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol. Likewise, no concerns have been reported from the agencies regarding the operation and/or conduct of the premises or the directors in the last year.
- There have been no issues raised in respect to the Building Code or the Resource Management Act.
- The premises is a grocery store with seven main aisles set in a vertical manner. The entrance is accessed from the car park. The Single Alcohol Area (SAA) is on the left-hand-side of the store and towards the rear. The SAA and the licensed area have not changed since the last renewal application. The licensed area is more precisely defined on the plan as received by Western Bay of Plenty District Council on 11th June 2019. There are no concerns with the design and layout of the premises or with the management of the premises. Signage is appropriate and clearly displayed and the applicant appears to have appropriate systems, staff, and training to comply with the law. The Inspector has no concerns as to layout of the premises, noting no designated area is required as the premises is a grocery store.
- The premises are well kept and has a tidy appearance within the building and from the outside. Katikati, a small town situated on State Highway 2 has a 24hr liquor ban in place for the majority of the town. The inspector is not aware of any concerns relating to noise, nuisance or vandalism relating to the store under the control of the current applicant. Similarly, there have been no negative reports from the police and no visual signs of crime in the local vicinity nor information to suggest the premises are associated with criminal behaviour. Therefore, there is no reason to believe the

amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Inspector after carrying out due diligence into the application reports that there is nothing to suggest that the granting of this application would not achieve the object of the Act.

The Local Alcohol Policy stipulates the maximum hours for an Off licence are: 9.00 am to 1.00 am the following day. Thereby the hours sought fall within the hours permitted under the local alcohol policy.

Subject to no new or contrary evidence being presented this application appears consistent with the Sale and Supply of Alcohol Act 2012 and the purpose of the Act therein meeting the criteria at Section 131 of the Act.

## **The Decision**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, grants an application by **Jones Retail Limited** trading as **Katikati Four Square** from 37-41 Main Road, Katikati a renewal of an **Off-Licence**; subject to the following conditions.

#### The Conditions:

 Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday: Hours: 7.00 am to 10.00 pm

- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day.
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. A properly appointed Certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 5. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
  - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

- 6. No alcohol may be sold other than:
  - (i) beer that complies with the appropriate New Zealand food standard for beer; or
  - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
  - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- 7. The "single alcohol area" for the premises is as described on the plan dated 11 June 2019 and attached at Appendix 'A' to the licence. The licensee must ensure that:
  - a. No alcohol is displayed, promoted, or advertised outside the single alcohol area; and
  - b. No products other than alcohol, low-alcohol and non-alcoholic beer, wine or mead are displayed, promoted, or advertised inside the single alcohol area.

Duration of this licence is for 3 years. Thereby this Licence will expire 17th March 2025.

# **The Application**

Amit Kooner Limited applies for renewal of an OFF Licence in respect of premises situated at 155A Jellicoe Street, Te Puke known as "Te Puke Liquor Spot."

The business is a franchised bottle store and meets the criteria of s.32(1)(b) of the Act in that it is retail premises from which more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else.

The entire premises is designated as a Supervised Area.

The current days and hours of operation are: **Monday to Sunday 9.00am to 10.00pm.** These hours are within the default national maximum trading hours but **NOT** the new Western Bay of Plenty Local Alcohol Policy as it pertains to off-licensed bottle stores. No changes are sought.

It is our understanding that all off licences will be required to close at 9.00pm from the 21st of August 2022.

## **Public Notification:**

The application was notified in the Te Puke Times on the 3<sup>rd</sup> and 10<sup>th</sup> of March 2022. objections from the public were received by the secretariat.

#### **REASONS FOR THE DECISION**

The Inspector reports that the applicant appears to have operated this bottle store compliantly over the renewal period.

Neither the Police, nor the Medical Officer of Health, raise any matters in opposition.

However, we are concerned to note that in 2020 there was an alleged incident where an intoxicated person was sold alcohol. Due to a technicality no enforcement action was undertaken.

It could be said that the applicant was fortunate not to receive another holding against their name. A 3<sup>rd</sup> negative holding within 3 years would result in a mandatory cancellation of licence and a 5 year ban from holding another.

Competent assessment of intoxication must occur at every sale.

There is still a need in Te Puke for discretionary conditions on off licences and, by consent, they will continue to be applied. For Te Puke Liquor Spot this means there must be no single serves of mainstream beers or RTDs and if products such as Godfather or Kingfisher Strong are sold, they are to be indelibly marked as prescribed in the conditions below.

As we said at the last renewal "Collectively the off-licensed outlets of Te Puke must step up and restrict the sales of alcohol to the street drinkers and to those that on-supply alcohol to them.

Decisive action is required by all of the towns alcohol outlets to bring about a positive change to the CBD of Te Puke township."

**Subject to the above**, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

## **DECISION**

The District Licensing Committee Chairman, acting pursuant to the sale and Supply of Alcohol Act 2012, **approves** an application by **Amit Kooner Limited** for renewal of an OFF Licence in respect of premises situated at 155A Jellicoe Street, Te Puke known as "Te Puke Liquor Spot," subject to conditions:

Section 21 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **TE PUKE CLUB INCORPORATED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **14 KING STREET**, **TE PUKE** and known as **TE PUKE CLUB INCORPORATED** for consumption on the premises, to any person who –

- a. is a member of the club; or
- b. is on the premises at the invitation of, and is accompanied by, a member of the club; or
- c. is a member of some other club with which the holder of the licence has an arrangement for reciprocal visiting rights for members.
- d. is on the premises at the invitation of, and is accompanied by, a member of some other club with which the club has an arrangement for reciprocal visiting rights for members, otherwise known as a guest of an authorised visitor.

The authority conferred by this licence must be exercised through a manager or managers appointed by the club in accordance with subpart 7 of part 2 of the Act.

#### CONDITIONS

This licence is subject to the following conditions:

2. Alcohol may only be sold on the following days and during the following hours:

#### Monday to Sunday:

Hours: 9.00 am to 1.00 am the following day.

- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4. While the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.
- 5. At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available.
  A minimum of three types of food should be available on the premises. Menus must be visible, and food should be actively promoted.
- 6. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- 7. The Licensee must provide information, advice, and assistance about alternative forms of transport available to patrons from the licensed premises;
- 8. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
  - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- 9. Is on the premises at the invitation of, and is accompanied by, a member of some other club with which the club has an arrangement for reciprocal visiting rights for members, otherwise known as a guest of an authorised visitor.

  - a. Ensure that no intoxicated persons are allowed to enter or to remain on the premises.
  - b. Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of alcohol to minors and intoxicated persons, at each entry and adjacent to every point of sale.

## **THE APPLICATION**

This application, submitted by **TE PUKE CLUB INCORPORATED**, seeks a renewed **CLUB LICENCE** in respect of premises situated at **14 KING STREET**, **TE PUKE**, and known as **TE PUKE CLUB INCORPORATED** (incorporated under the Incorporated Societies Act 1908 30 August 1923). Its principal entrance is accessed from car parking off Jubilee Park car park, Te Puke.

There is a liquor ban in Te Puke, which includes Jubilee Park. The actual club and accompanying bowling greens are defined as commercial under the district plan. The surrounding premises are also zoned as commercial under the district plan.

The general nature of the business to be undertaken is that of a **CLUB LICENCE - CLASS 2.** Days and hours sought are Monday to Sunday 09.00a.m. until 01.00a.m.

The Club's current licence 022/RENCL/7541/2019 has an 30.3.2022 expiry date.

The applicant does not hold an off-licence.

The applicant shares reciprocal rights with clubs under the Clubs NZ banner, who facilitate reciprocal arrangements between its members.

The Club's Secretary is Kylie Stott 022/CERT/7752/2019.

The Council's records show this is the fifth application since 2012.

# **Reasons for the Decision**

The application was publicly notified in the Bay of Plenty Times, 10 March 2022 in the Bay of Plenty Times, with no public objections being submitted.

Neither the Police (reporting 12<sup>th</sup> May 2022) nor the Ministry of Health (reporting 22<sup>th</sup> March 2022) oppose this application.

Fire Emergency NZ have no opposition to this application nor does the Inspector who reports:

- An inspection of the premises was conducted on Thursday 10 March 2022 at which time
  he met the duty manager. The applicant appears to be aware of the responsibilities
  under the Act.
- No information has come to light over the last renewal period to indicate there have been any issues or concerns with how the sale and supply of alcohol has been managed.
- He has no concerns with the applicant's suitability.
- There have been no issues raised in regard to the Building Code or the Resource Management Act.
- He has no concerns with the layout of the Club. As a bowling club the club house is relatively large for a club, but the majority of the tables and chairs are stationed close to the bar area. There are a couple of snooker tables in the club as well. The club house is an open plan design, so the duty manager can easily oversee members consuming alcohol. The overall licensed area is the club house and bowling greens. The licensed area is as the floorplan as received by Western Bay of Plenty District Council on 17 March 2022. No designated areas have been requested. The premises operates as a club and the principal purpose of the club is the promotion of sports, there is no need under legislation to have a designated area. No BYO alcohol is permitted on the premises whilst the bar is in operation. The club also has snooker tables as well as lawn bowls. Thus, there are no concerns with the design and layout of the premises.
- The applicant appears to have appropriate systems, staff, and training to comply with
  the law. At present there is only qualified duty manager recorded as working for the
  club. The club has a manager's register. Providing the duty manager is monitoring the
  consumption of alcohol, he sees little risk in anyone being intoxicated, as long as the
  duty manager is actively overseeing the entire licensed area.
- When visiting the premises on Thursday 10 March 2022 the duty managers name plate was displayed on the wall behind the bar. The host responsibility policy was displayed behind the bar. The club has plans to train more bar staff to be duty managers. Free water, low and non-alcoholic drinks were stocked and readily available. A menu was displayed for the food from the kitchen. The kitchen had food already stocked in the freezers. The club has access to taxi information and a courtesy van. All the signage was clearly displayed. The applicant appears to have appropriate systems, staff, and training to comply with the law.
- There are no concerns have been brought to his attention with membership. In the last three years he has not received any complaints regarding the activities of the club interfering with the harmony of the local community.
- He has no concerns with where the club is situated or the operations of the club affecting the local inhabitants nor is he aware of any concerns relating to noise, nuisance or vandalism relating to the club.

- There are no negative reports from the police and no visual signs of crime at the club. There is no information to suggest the premises are associated with criminal behaviour.
- Jubilee Park is often used for freedom camping, the homeless and the street drinkers tend to congregate at the park as a meeting spot to consume alcohol. At no point in the last three years has the club had anything to do with the activities taking place in the park.
- As the premises are clean, tidy, and well maintained by the club he has no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

After carrying out due diligence and considering this application, the Inspector reports there is nothing to suggest that the granting of this application would not achieve the object of the Act.

The applicant does not seek any change to the licensed hours, which currently are:

Monday to Sunday:

Hours: 9.00 am to 1.00 am the following day.

Maximum hours:

112 Hours a week.

The Local Alcohol Policy stipulates the maximum hours for a Club licence are: 9.00 am to 1.00 am the following day. Thereby the hours sought fall within the hours permitted under the local alcohol policy.

Subject to no new or contrary evidence being presented this application appears consistent with the Sale and Supply of Alcohol Act 2012 and the purpose of the Act therein meeting the criteria at Section 131 of the Act.

## **The Decision**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, grants an application by **Te Puke Club Incorporated** a renewal of an **On-Licence** - in respect to premises situated at 14 King Street, Te Puke: subject to the following conditions.

## **The Conditions:**

- (a) Alcohol may only be sold on the following days and during the following hours:

  Monday to Sunday: Hours: 9.00 am to 1.00 am the following day.
- (c) Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- (d) While the premises are open for the sale and supply of alcohol may be consumed on the premises.
- (d) At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available on the premises. Menus must be visible, and food should be actively promoted.

- (e) The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- (f) The Licensee must provide information, advice, and assistance about alternative forms of transport available to patrons from the licensed premises;
- (g) The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
  - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- (h) Is on the premises at the invitation of, and is accompanied by, a member of some other club with which the club has an arrangement for reciprocal visiting rights for members, otherwise known as a guest of an authorised visitor.
- (i) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
  - (a) Ensure that no intoxicated persons are allowed to enter or to remain on the premises.
  - (b) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of alcohol to minors and intoxicated persons, at each entry and adjacent to every point of sale.

Duration of this licence is for 3 years. Thereby this Licence will expire 30th March 2025.

# **The Application**

This application, submitted by **THE JELLICOE LIMITED**, seeks the renewal of an **ON LICENCE** in respect of premises situated at **110 JELLICOE STREET**, **TE PUKE**; known as **TE PUKE HOTEL**.

The Hotel is situated at the corner of Jellicoe Street and Jocelyn Street, Te Puke and its principal entrance is accessed from 120 Jellicoe Street, Te Puke.

The applicant is a private limited company (No. 1003167), incorporated on 24<sup>th</sup> November 1999.

The general nature of the business undertaken is that of an **ON LICENCE - HOTEL.** The Days and hours sought are Monday to Sunday 09.00a.m. to 01.00a.m.

The business has been trading with an On-Licence since 14 April 2001. Thereby this is the eighth on-licence application. It's current Licence 022/RENON/7547/2019 has a 14 April 2022 expiry date.

The applicant does not seek any changes to the licence.

McGregor Peat Investments Limited, are the owners of the Premises – Mr Ashley Peat and Mrs Suzanne Leonie Peat are the two directors, both of whom are also the shareholders of the Te Puke Hotel.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

## **Reasons for the Decision**

The application was publicly notified in the Bay of Plenty Times on the 10<sup>th</sup> and 22<sup>nd</sup> May and no public objections have been submitted.

Neither the Police (reporting 12 May 2022) nor the Ministry of Health (reporting 22<sup>nd</sup> March 2022) oppose this application.

Fire Emergency NZ has no opposition to this application nor does the Inspector who reports:

- A general discussion held with the director and duty manager on Thursday 10 March 2022 during an inspection of the premises showed that there're no concerns with how the premises was being managed at that time.
- He has no need to question the director's suitability in relation to this premises.
- No information has come to light in the last renewal period regarding the operation of the premises and no concerns have been reported from the agencies regarding the conduct of the premises or the director.
- There have been no issues raised regarding the Building Code or the Resource Management Act.
- The first upper floor is where the 15 hotel rooms are situated. The Highway Bar on the ground floor is essentially a tavern styled premises with 18 gaming machines in the far back corner and the entire floor space is the licensed area (more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 4 March 2022). The bar area is relatively open plan. There are two pool tables, 2 TV screens showing regular TV and sports. There is also a single dart board. There are approximately 10 tables and accompanying chairs interspersed around the main floor area and a lounge suite. The background music is deliberately classic in nature to suite the ears of its older clientele. The hotel rooms can be accessed from the bar area, but they also have an additional separate entrance as well. The entire upper floor where the hotel rooms are, is unlicensed. He has no concerns with the design and layout of the premises providing the licensed area is adequately managed by the duty manager. There is a gaming area with 18 gaming machines.
- He has known the director (Mrs Suzanne Leonie Peat) for the last five years and has full confidence in her ability to comply with the Act and train her team to manage the customers.
- The site visit showed that all the required signage was clearly displayed. The duty manager's name was prominently displayed. The duty manager was present on the premises and overseeing the licensed area. The licence was displayed in the entrance. The host responsibility policy was displayed behind the bar. Menus were visible on the bar. Behind the bar he could easily see non-alcoholic and low alcoholic beverages in

the fridge. Free water was also available. The manager's register was kept behind the bar.

- Alternative transportation was in the form of taxi information.
- Situated in the main high street in the town centre of Te Puke, there are four bottle stores, one grocery store, three taverns and three ethnic styled restaurants. Slightly set back from Jellicoe Street there are also two supermarkets. All these premises sell alcohol. In addition, there are still several premises still operating, such as cafes, bakeries, bookstores, chemists, and dollar stores. Te Puke town centre is subject to a liquor ban and the immediate area is zoned as commercial.
- The town centre has a history of issues with street drinkers and the subsequent problems that arise from intoxicated people behaving poorly in the street however no information has come to light to suggest a correlation between this premises and the street drinkers.
- He is unaware of any concerns relating to noise, nuisance or vandalism associated with the premises in the last year. There is no visual evidence of anti-social behaviour such as discarded bottles, cans, or litter to indicate the parking facilities at the front of the premises are being used to pre-load. The hotel and bar have had a revamp in recent years. There is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.
- The application implies there are four duty managers recorded as working for the
  premises. The duty manager's register is kept behind the bar. The director is responsible
  for training needs, which is primarily conducted by the experienced duty managers. The
  applicant appears to have appropriate systems, staff, and training to comply with the
  law.

Thereby the Inspector having carried out due diligence into the application and based on the information provided reports that the application meets the criteria in the Act recommending that this licence be renewed.

The hours comply with the requirements of the Local Alcohol Policy, as it applies to the premises that stipulates the maximum hours for an On-licence are Monday to Sunday 9.00 am to 1.00 am the following day.

Subject to no new or contrary evidence being presented this application appears consistent with the Sale and Supply of Alcohol Act 2012 and the purpose of the Act therein meeting the criteria at Section 131 of the Act.

## **The Application**

Thiara Liquor Limited applies for the renewal of the OFF Licence in respect of premises situated at 161 Jellicoe Street, Te Puke known as "Thirsty Liquor Te Puke."

The business is a franchised bottle store and meets the criteria of s.32(1)(b) of the Act in that it is retail premises from which more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else.

The entire premises is designated as a Supervised Area.

The current days and hours are: Monday to Sunday 9.00am to 10.00pm. No Changes are sought.

These hours are within the default national maximum trading hours but NOT the newly adopted Western Bay of Plenty Local Alcohol Policy as it pertains to off licensed bottle stores.

We understand that the licensed hours will become **Monday to Sunday 9.00am to** 9.00pm from the 21st of August 2022.

## **Public Notification:**

The application was notified in the Te Puke Times on the 10<sup>th</sup> and 17<sup>th</sup> of March 2022. No objections from the public were received by the secretariat.

#### **REASONS FOR THE DECISION**

Neither the Police, nor the Medical Officer of Health, raise any matters in opposition.

The Inspector reports that the owners have been operating compliantly during their first 'probationary' year of operation.

As we required when first granting this licence, the Inspector has impressed upon them the problem with the street drinkers in the Te Puke township who regularly breach of the alcohol ban.

We are pleased to see that this applicant continues to embrace the need for additional discretionary conditions, and by consent they will be applied to this licence renewal. For **Thirsty Liquor Te Puke** this means there must be no single serves of mainstream beers or RTDs and if products such as Godfather or Kingfisher Strong are to be sold, that they are to be indelibly marked as prescribed in the conditions of licence.

We also add the condition imposing a designation of Supervised Area that appears to b have been left off the previous decision/licence.

Collectively, the off-licensed outlets of Te Puke must step up and restrict the sales of alcohol to the street drinkers and to those that on-supply to them.

On-going decisive action is required by all parties to bring about a positive change to the CBD of Te Puke township.

Subject to the above, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

I consider the application on the papers.

The applicant has provided a basic menu of the food options and low and non-alcoholic beverages available on the premises.

#### Reasons for the Decision

The applicant has operated this business for a little over 4 years now and appears to be operating compliantly other than a fight at the rear of the premises in 2019.

We also note that the applicant, via their agent, continues to seek a Restricted Area designation for the gaming room.

As we said last time the Committee can only impose a Restricted Area designation if the **exclusive use** of the area is the sale, supply and consumption of alcohol.

Clearly that is not the case in TABs and pokie rooms. The whole of the licensed area will be designated as **Supervised Area**. If the licensee chooses to declare the gaming areas as Restricted under their responsibilities under the Gambling Act 2003 that is a matter for them to consider.

We also place the applicant on notice that to retain the status of a tavern they must operate principally for the provision of alcohol and other refreshments.

If gaming revenue is the principal income source, then they are in breach of Section 67 of the Gambling Act 2003 that requires that class 4 venues are <u>not used mainly</u> for operating gaming machines and Council's Gambling Venue Policy 5.5 that states the primary activity of Class 4 venues shall not be gambling.

Neither the Police nor the Medical Officer of Health has any matters in opposition.

**Subject to the above**, I am satisfied as to the matters to which we must have regard as set out in s131 of the Act.

Accordingly, I will determine the matter on the papers.




