Section 21 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **MATAKANA ISLAND RECREATION AND COMMUNITY INCORPORATED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **OPUREORA ROAD, MATAKANA ISLAND** and known as **MATAKANA ISLAND RECREATION AND COMMUNITY CLUB** for consumption on the premises, to any person who –

- (a) is a member of the club; or
- (b) is on the premises at the invitation of, and is accompanied by, a member of the club; or
- (c) is a member of some other club with which the holder of the licence has an arrangement for reciprocal visiting rights for members.

The authority conferred by this licence must be exercised through a manager or managers appointed by the club in accordance with subpart 7 of part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied from the premises for consumption on the premises only on the following days and hours:

Monday to Saturday	10:00 am to 1:00 am the following day
Sunday	10:00 am to 8:00 pm
2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
3. At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available on the premises. Menus must be visible, and food should be actively promoted.
4. The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
5. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
6. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;



The general nature of the business to be undertaken is that of a **CLUB LICENCE - CLASS 2.**

The applicant is an incorporated society and is incorporated under the Incorporated Societies Act 1908 on 18 April 1990.

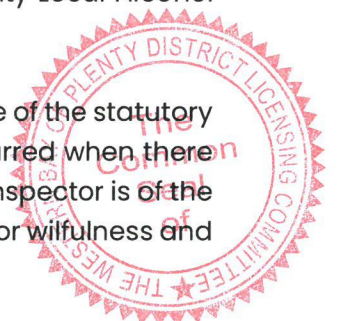
The application was publicly notified in the Bay of Plenty Times on 22 April 2022. No objections were received from members of the public.

No changes are sought to the existing authorised hours which are:

Monday to Saturday	10:00 am	to	1:00 am the following day
Sunday	10:00 am	to	8:00 pm

These hours are within the operative Tauranga and Western Bay of Plenty Local Alcohol Policy as it relates to Club Licences.

It is noted that the public notice for this application was made well outside of the statutory time frame however, the Inspector has submitted that the situation occurred when there was a change of personnel responsible for the application process. The Inspector is of the view, given the location of this club, that there has been no disadvantage or wilfulness and that a waiver pursuant to s.208 is appropriate. I agree.



The applicant has supplied a list of food options as well as low and non-alcoholic beverages that are available when the premises are open for the sale and supply of alcohol.

Neither the Police nor the Medical Officer of Health has raised any matters in opposition.

REASONS FOR THE DECISION

The principal activity is that of a community club serving the club members and their visitors on Matakana Island. The principal entrance is accessed from the car parking off Opureora Road.

The licensed area is the entire floor area of the club house only and is more precisely identified on the plan date stamped as received by Western Bay of Plenty District Council on 6 August 2022.

The Inspector has reported he has received no complaints regarding the club activities or the actions of its members. In addition, the Inspector reports that to date, no issues have been identified with the operation of the premises in accordance with the object of the Act.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

DECISION

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by the **Matakana Island Recreation and Community Incorporated** for renewal of the Club-licence in respect of premises situated at **Opureora Road, Matakana Island** and known as the "**Matakana Island Recreation & Community Club**", subject to conditions.



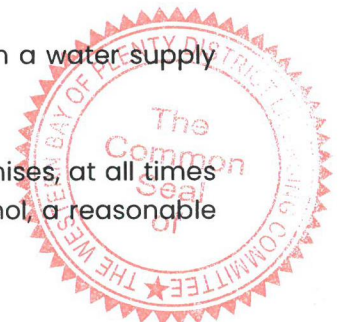

We consider the renewal on the papers and refresh the licence condition to reflect best practice.

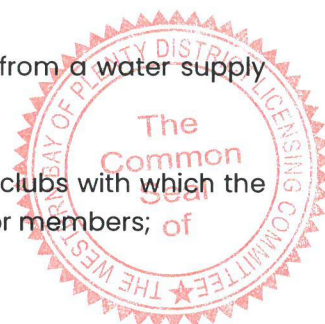

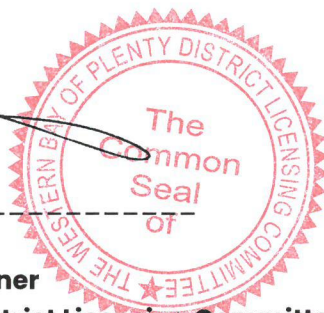

The application to vary the licensed area was publicly notified in the Katikati Advertiser on the 8th and 15th of September 2022 and no objections were received from members of the public.

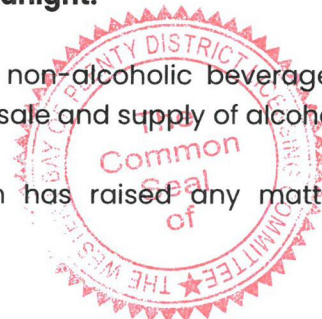

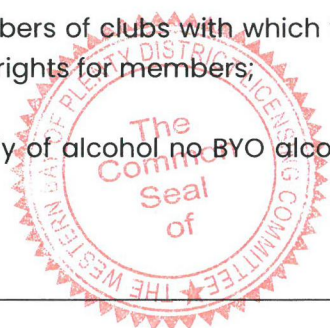

7. The licensee must provide information, advice, and assistance about alternative forms of transport available to patrons from the licensed premises.
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by persons using the premises.
