Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **JENNY BIRD GRANT** (the licensee) is authorised to sell and supply alcohol on the premises situated at **30A MAIN ROAD, KATIKATI** and known as **CAFE @ THE BALCONY**, to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not present on the premises to dine.
2. Alcohol may be sold only on the following days and during the following hours:
Monday to Saturday: Hours – 9.00 am to 5.00 pm
3. Free drinking water is to be always available to customers from the serving counter.
4. No alcohol is to be sold and supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine on the premises;
5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted;
7. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
8. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
9. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

This licence continues in force until 11 March 2020 unless renewed.

IN THE MATTER of an application by **JENNY BIRD GRANT** pursuant to s.100 of the Act for an On Licence for premises situated at 30A Main Road, Katikati, known as the Café @The Balcony.

BEFORE THE WESTERN BAY OF PLENTY DISTRICT LICENSING COMMITTEE

THE APPLICATION

The application, submitted **JENNY BIRD GRANT**, is for a new on-licence Class 3 Restaurant to sell liquor onsite in relation to another licence as per the Sale and supply of Alcohol Act 2012 from the rented, situation at 30A Main Road, Katikati premises and known as the Café @ The Balcony.

Hours sought are:

Monday to Saturday 9.00.a.m. to 5.00.p.m.

The principal business is providing meals to the public for eating on the premises.

The criteria found at Section 105 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

REASONS FOR THE DECISION

The application was publicly notified in the Katikati Advertiser 6th December 2018 and again on 13rd December 2018 and did not attract any objections.

Neither of the reporting agencies have opposed this application.



The applicant is seeking conditions consistent with the style of on-licence for the area and as such the Inspector considers that the sale and supply of alcohol under these conditions are consistent with the purpose of the Act and meets the criteria at section 105 of the Act.

The Inspector does not oppose this application reporting that:

The applicant is a natural person and meets the criteria under section 28 (1) a.

A general discussion was held on 30 November 2018 with the duty manager who is managing the cafe and he has spoken to the licensee over the phone.

A certificate of compliance attached to the application as required under section 100(f) of the Act shows that the proposed use of the premises meets the requirements of the Resource Management Act 1991 and the building code.

The application meets the requirements of The Local Alcohol Policy

The named duty manager (Ma Teresa De Los Santos) has been working at the café since February 2017 and has been a certificated duty manager since 18 June 2018.

Under the previous owner no information came to light to indicate there were any problems with the management of the sale, supply and consumption of alcohol at the café.

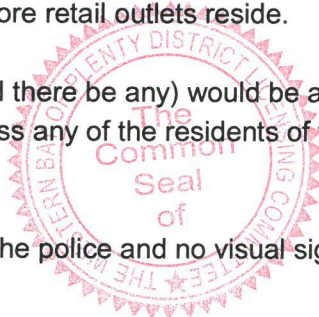
The applicant appears to have appropriate systems, staff, and training to comply with the law.

A varied choice of food, including cabinet food, breakfast, lunch and Thai options are available and there is no dinner menu as the café closes at 5.00 pm.

The café is situated above the ANZ bank in the heart of Katikati town centre. Access is by way of a set of stairs leading up from a court yard of shops to a first floor balcony, where the café and more retail outlets reside.

It is highly unlikely any noise (should there be any) would be able to travel through trees and buildings to distress any of the residents of the two roads mentioned.

There are no negative reports from the police and no visual signs of crime in the local vicinity.



There is no visual evidence of anti-social behaviour such as discarded bottles, cans or litter to indicate the courtyard or surrounding area is being used to pre-load or used to consume alcohol. There are also no signs to indicate the surrounding amenity and good order is suffering or will suffer.

There is no reason to believe that the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence.

There are no concerns with goods and/or services the applicant provides at the premises and the hours of operation are restricted to Monday to Saturday –
Hours: 9.00 am to 5.00 pm

There is no reason to believe that the applicant is not suitable to hold a licence.

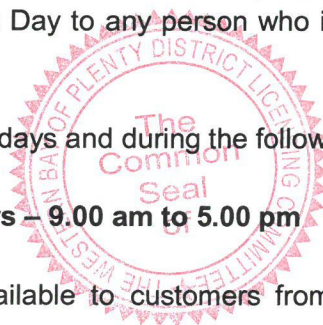
Thereby the Inspector after inquiring into the application and based on the information provided he reports that the application meets the criteria in the Act. Subject to no new or contrary evidence being presented, he does not oppose this application.

Thereby I am satisfied as to the matters to which we must have regard as set out in s.105 of the Act.

1. No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not present on the premises to dine.
2. Alcohol may be sold only on the following days and during the following hours:
Monday to Saturday: Hours – 9.00 am to 5.00 pm
3. Free drinking water is to be always available to customers from the serving counter.



4. No alcohol is to be sold and supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine on the premises;
5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted;
7. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
8. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

This Licence expires on 11th March 2020.

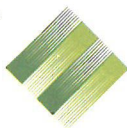

THE APPLICATION

This is an application by **SALT & PEPPER CATERING LIMITED** for a new **ON LICENCE** in respect of premises situated at **UNIT 5, 62 MAIN ROAD, KATIKATI**, to trade as **CENTRAL PARK BAR & KITCHEN.**

This application has arisen through a change of ownership resulting in a new business being established on the premise.

The general nature of the business to be undertaken is that of a **ON LICENCE - CLASS 2 RESTAURANT** as it will be a restaurant with a bar. The principal business is to provide meals to the public for eating on the premises.

Days and hours sought:

Monday to Sunday 9.00a.m. to 1.00a.m. the following day.

Thereby the criteria found at Section 105 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

REASONS FOR THE DECISION

The application was publicly notified in the Katikati Advertiser 21st February 2019 and again on 28 February 2019 and did not attract any objections. It is noted that the Public Notice communication to the applicant incorrectly stated that there should be no more than 10 working days between the first and second notice instead of 10 days after the first publication as per section 36(b) of Sales and Supply of Alcohol regulations. Thus, the objection period expired 14th March 2019. A waiver is thereby sought by the Inspector for this administration failing. I rule that this error is not fatal to the application nor has the public's right to be properly informed been comprised.

Neither of the reporting agencies have opposed this application.

The Inspector reports that:

A site visit and general discussion with the applicant took place 21 February 2019.



A Certificate of Compliance required under section 100(f) of the Act, issued 25th March 2019, shows that the proposed use of the premises meets the requirements of the Resource Management Act and the Building Code.

Under the previous owner no information came to light to indicate there were any problems with the site, management of the sale, supply and consumption of alcohol at that café.

The applicant appears to have appropriate levels of staff and management to run the business effectively.

The building is situated in the Katikati town centre and there is no concern of excessive noise or overcrowding.

There is no reason to believe that the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence.

There is no reason to believe that the applicant is not suitable to hold a licence.

The applicant is seeking conditions consistent with the style of an on-licence for the area and as such the Inspector considers that the sale and supply of alcohol under these conditions are consistent with the purpose of the Act and meets the criteria at section 105 of the Act.

The Inspector after inquiring into the application and based on the information provided and subject to no new or contrary evidence being presented, does not oppose this application.

Thereby I am satisfied as to the matters to which we must have regard as set out in s.105 of the Act.

THE DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), approves an On-Licence application by **Salt & Pepper Catering Limited** to sell and supply alcohol, on the premises at **Unit 5 Main Road, Katikati** as a Class 2 Restaurant subject to the following conditions.

1. No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not present on the premises to dine.
2. Alcohol may be sold only on the following days and during the following hours:
Monday to Sunday: Hours – 9.00 am to 1.00 am the following day
3. Free drinking water is to be always available to customers from the serving counter.
4. The following steps must be taken to promote the responsible consumption of alcohol:

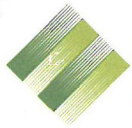

Accordingly, the application and the supplied information must satisfy all the matters to which we must have regard as set out in s.131 of the Sale and Supply of Alcohol Act 2012 (the Act).

Reasons for the Decision applies to this application

The application was publicly notified in the The Bay of Plenty Times 21st December 2018 and did not attract any objections.

Neither of the reporting agencies have opposed this application.

The Inspector does not oppose this application reporting:

- There have been no issues raised in regard to the building code or the Resource Management Act 1991.
- There were no compliance issues found during inspections in the past twelve months.



- When visiting the premises 22nd February 2019 all required signage was clearly displayed and a host responsibility policy was in place. Food, low and non-alcoholic beverages, and alternative forms of transport were available. There was no concern for excessive noise or overcrowding, nor does the club create any noise, nuisance or vandalism issues in the area.
- The applicant appears to have appropriate systems, staff, and training to comply with the law.
- The manner in which the applicant has sold, displayed, advertised or promoted alcohol has not caused concern for the reporting agencies.
- There is no reason to believe that the amenity and good order of the locality would be likely to be increased, to more than a minor extent, by the effects of a refusal to renew the licence.
- The Inspector considers that the sale and supply of alcohol under these conditions are consistent with the purpose of the Act and meets the criteria at section 131 of the Act.
- The applicant is aware of its responsibilities under the Act.
- The Inspector does not oppose the design and layout of the premises.
- The manner in which the applicant has sold, displayed, advertised or promoted alcohol has not caused concern for the reporting agencies.

Thereby the Inspector has inquired into the application, and based on the information provided, the application meets the criteria in the Act. Subject to no new or contrary evidence being presented, the Inspector does not oppose this application.

The Decision

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **Matakana Island Recreation and Community Incorporated** for a renewal of the Club Licence in respect of premises situated at **Opureora Road, Matakana Island**, subject to the following conditions:

6. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
7. The Licensee must display:

- a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;

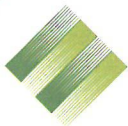

The Application

J N Sons Enterprises Limited ("the licensee") applies for the renewal of the ON Licence in respect of premises situated at 81 Jellicoe Street, Te Puke known as the "Stadium Sports Bar."

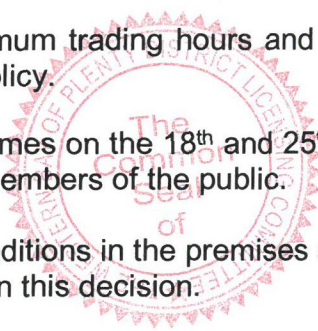
They also seek to amend the licensed area to **exclude** a shared exit with an adjacent business.

The business is tavern with a TAB and gaming machines. The current licensed days and hours are **Monday to Sunday 10.00am to 1.00am the following day. No changes are sought.**

These hours fit within both the default national maximum trading hours and the Tauranga and Western Bay of Plenty Local Alcohol Policy.

The application was publicly notified in the Te Puke Times on the 18th and 25th of October 2018 and no objections were received from members of the public.

However, a 'complaint' was received alleging filthy conditions in the premises and an abusive duty manager. We discuss this letter later in this decision.



The applicant has provided a basic menu of the food options and low and non-alcoholic beverages available on the premises.

An inadequate plan of the proposed amended licensed area has been provided.

Reasons for the Decision

The applicant has operated this business for a little over 12 months now but **has come to notice in an adverse manner.**

On 15 November 2018 Police located a grossly intoxicated male asleep at a leaner with a partially consumed 750ml bottle of beer in front of him. It appears from the Police notes, that the certificated duty manager denied responsibility for allowing the person to become intoxicated and blamed other patrons for supplying him with alcohol.

The inspector reports that no further action was taken on the basis that the duty manager had called a taxi for the patron.

This is a disappointing response as a clear offence is disclosed of allowing a person to become intoxicated on licensed premises and allowing an intoxicated person to remain on licensed premises. Sections 249 & 252 refers.

The only defence to 252 is if the affected person is taken to a place of safety and denied access to alcohol. From the evidence before the Committee this was not done.

In addition, the letter of 'complaint' received does not reflect well on the applicant and its staff. As the alleged offender of the behaviour complained of, has left the business, the letter writers seeks no further action.

We say this: operating a tavern is a high-risk activity and must be managed and supervised overtly by competent, experienced staff. For these issues to arise in the first 'probationary' year of business reflects poorly on the applicant.

Also, at the renewal inspection the Inspector discovered that the exit of the adjacent café was included in the current licensed area of this business. This is unacceptable as underaged staff from the café were forced to walk through the smoking area that is designated as a Supervised Area.

On our request a new plan has now been provided showing the revised licensed area.

We also note that the Gaming Area and TAB were designated as Restricted Areas when the licence was first granted in November 2017. The Committee can only impose a Restricted Area designation if the **exclusive use** of the area is the sale, supply and consumption of alcohol.

Clearly that is not the case in TABs and pokie rooms. The whole of the licensed area will be designated as **Supervised Area**. If the licensee chooses to declare the gaming areas as Restricted under their responsibilities under the Gambling Act 2003 that is a matter for them to consider.

We do expect a vastly improved level of compliance in future from this applicant and regular compliance inspections by the regulatory agencies.

Neither the Police nor the Medical Officer of Health has any matters in opposition.

Subject to the above, I am satisfied as to the matters to which we must have regard as set out in s131 of the Act.

Accordingly, I will determine the matter on the papers.

The Application

This is an application by **Graduate Enterprises Limited** for the renewal and variation of an OFF Licence in respect of premises situated at 33 Wilson Road, Waihi Beach, known as "Waihi Beach Four Square.

The applicant has been operating this store for 14 years.

The current days and hours are: **Monday to Sunday 7.00am to 10.00pm**. No changes are sought.

These are within the default national maximum trading hours for off licences of 7am to 11pm and within the adopted Tauranga and Western Bay of Plenty Local Alcohol Policy.

The business is a large open-plan store with shelves and aisles holding food products and other household goods on all sides and a single alcohol area (SAA) down one side of the store.

The application was notified in the Bay of Plenty Times on the 5th and 12th of January 2019 and no objections were received from members of the public.

The applicant has submitted verified sales figures for the 12 months period immediately prior to lodging the application that indicate that the principal activity is the sale of food products.

The Police do not oppose the renewal however the Medical Officer of Health initially opposed the renewal believing the SSA was non-compliant. They have since been satisfied that the small increase in the Single Alcohol Area sought is reasonable.

REASONS FOR THE DECISION

The application is complete and contains all the necessary considerations as required under s.127 of the Act. It was duly advertised, and no public objections were received.

The agencies appear to be satisfied that this business is a grocery store and that the amenity and good order of the area has not been adversely affected by more than a minor extent.

This stance, along with the other criteria outlined in Section 33(2) of the Act, assists the Committee to also be satisfied that the business is that of a grocery store.

The redefined SAA is clearly displayed on the new plan dated 26 February 2019. The MOoH opposition has been withdrawn.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.120 and 131 and s.112-115 of the Act.

Accordingly, I deal with the matter on the papers.

DECISION

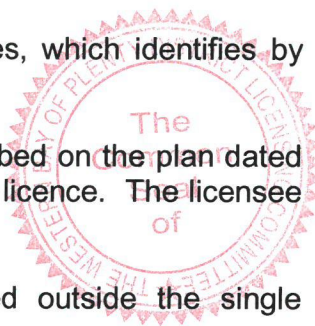
The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by Graduate Enterprises Limited for renewal and variation of an OFF Licence in respect of premises situated at 33 Wilson Road, Waihi Beach, known as "Waihi Beach Four Square" subject to conditions.

We also refresh the licence conditions to reflect best practice and the recent amendment to the Act permitting non-alcoholic beers to be displayed in the SAA.

Conditions:



The licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, and supplied free as a sample for consumption on the premises, only on the following days and hours: **Monday to Sunday 7.00am to 10.00pm**;
2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day;
3. No alcohol may be sold other than –
 - a. beer that complies with the appropriate New Zealand food standard for beer; or
 - b. mead that complies with the appropriate New Zealand food standard for mead; or
 - c. fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - d. grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - e. a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted;
4. While alcohol is being supplied free as a sample, water is to be provided to patrons at no cost from a water supply prominently situated on the premises;
5. A properly appointed Certificated, or Acting or Temporary, Manager must be on duty, at or nearby the point of sale, at all times when the premises are open for the sale and supply of alcohol.
6. The Licensee must display signage as follows:
 - a. At every point of sale signage detailing the restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principle entrance to the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
7. The “single alcohol area” for the premises is as described on the plan dated **26 February 2019** and attached at Appendix ‘A’ to the licence. The licensee must ensure that:
 - a. No alcohol is displayed, promoted or advertised outside the single alcohol area; and

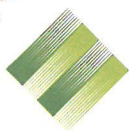


- b. No products other than alcohol, low-alcohol and non-alcoholic beer, wine or mead are displayed, promoted or advertised inside the single alcohol area.

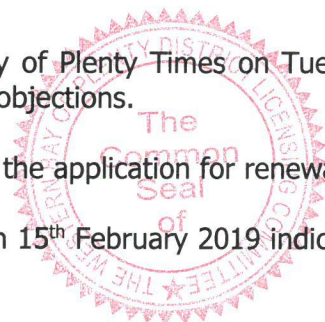
Accordingly, the application and the supplied information must satisfy all the matters to
which we must have regard as set out in s.131 of the Sale and Supply of Alcohol Act 2012.

REASONS FOR THE DECISION

The application was publicly notified in the Bay of Plenty Times on Tuesday February 5th
and February 12th 2019 and did not attract any objections.

Neither of the reporting agencies have opposed the application for renewal.

The Inspector when reporting on the application 15th February 2019 indicated that he does
not oppose this application reporting that:



- There have been no issues raised in regard to the building code or the Resource Management Act 1991.
- There were no compliance issues found during inspections in the past twelve months.
- When visiting the premises all required signage was clearly displayed and a host responsibility policy was in place. Food, low and non-alcoholic beverages, and alternative forms of transport were available. There was no concern for excessive noise or overcrowding, nor does the club create any noise, nuisance or vandalism issues in the area.
- The applicant appears to have appropriate systems, staff, and training to comply with the law.
- The manner in which the applicant has sold, displayed, advertised or promoted alcohol has not caused concern for the reporting agencies.
- There is no reason to believe that the amenity and good order of the locality would be likely to be increased, to more than a minor extent, by the effects of a refusal to renew the licence.
- The Inspector considers that the sale and supply of alcohol under these conditions are consistent with the purpose of the Act and meets the criteria at section 131 of the Act.
- The applicant is aware of its responsibilities under the Act.
- The Inspector does not oppose the design and layout of the premises advising the applicant appears to have appropriate systems, staff, and training to comply with the law.
- The manner in which the applicant has sold, displayed, advertised or promoted alcohol has not caused concern for the reporting agencies.
- The Fire Risk Manager has visited the building and reports it has an approved and operative evacuation system.
- Section 60(1) (b)(c) allows a licence to be issued subject to a condition allowing alcohol to be sold or supplied to a person who is on the premises at the invitation of or at the invitation of, and/or is accompanied by, a member of some other club with which the club has an arrangement for reciprocal visiting rights for members.

Thereby the Inspector has inquired into the application, and based on the information provided, the application meets the criteria in the Act. Subject to no new or contrary evidence being presented, the Inspector does not oppose this application.

Thereby I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.
