



Renewal of On Licence

Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **MONTRE GROUP LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **160 OMOKOROA ROAD, OMOKOROA** and known as **MONTRE-ATELIER DU CAFE**, to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:
Monday to Sunday 11.00am to 10.00pm;
2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;
6. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises;

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

The Application

Montre Group Limited (“the licensee”) applies for the variation and renewal of the ON Licence in respect of premises situated 160 Omokoroa Road, Omokoroa known as “Montre-Atelier du Cafe.”

The business is primarily a low-risk daytime and early evening café. The current licensed hours are **Monday to Sunday 9.00am to 10.00pm** and a variation is sought to reduce the licensed hours to **11.00am to 10.00pm**.

These hours fit within both the default national maximum trading hours and the Tauranga and Western Bay of Plenty Local Alcohol Policy. If they wish to open for coffee and food earlier than 11.00am that is a matter for them.

The application was publically notified in the Katikati Advertiser on the 9th of May 2019 and no objections were received by the DLC Secretariat from members of the public.

The applicant has provided comprehensive menus of the food options and low and non-alcoholic beverages available on the premises.

Reasons for the Decision

The applicant has operated this business for 12 months now and has not come to notice in an adverse manner.

Neither the Police nor the Medical Officer of Health has any matters in opposition.

The inspector reports that the amenity and good order of the area has not been adversely affected by more than a minor extent by this low risk activity.

I am satisfied as to the matters to which we must have regard as set out in s120 & 131 of the Act.

Accordingly, I will determine the matter on the papers.

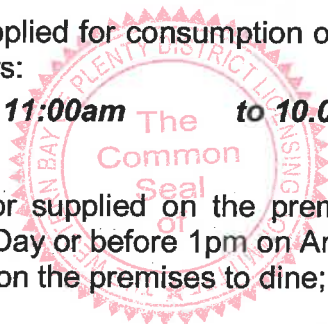

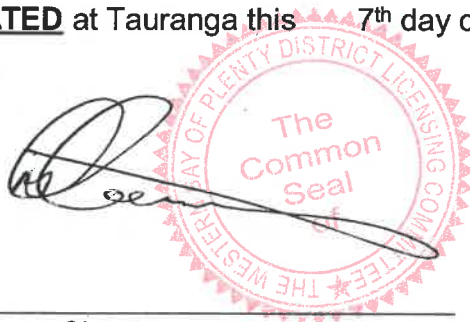

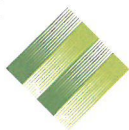

Menus must be visible, and food should be actively promoted;
6. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises;

The Application

This is an application received from **T SINGH LIMITED** for a renewal of a **ON LICENCE** (022/ON/06/2015 expiring 15th May 2019). The applicant is a NZ registered private limited company (4358498).

This application is in respect of premises situated at **76 MAIN ROAD, KATIKATI**, trading as **MEHTAB INDIAN RESTAURANT**. The general nature of the business to be undertaken is that of a **ON LICENCE - CLASS 3 RESTAURANT**.

Days and hours sought:

MONDAY TO SUNDAY **10:00a.m.** **to** **01:00a.m.**

The Applicant does not seek any changes to the licence.

The Restaurant Menu and the Property Owner's Approval were attached to the application.

A waiver was granted on 10 May 2019 to proceed with the application.

Thereby the criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

Reason for the Decision

The application was publicly notified in The Katikati Advertiser on the following date:

- Second Notice Not required

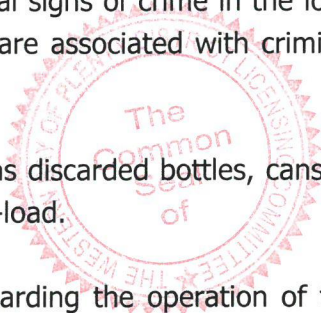
The objection period expired on 7 June 2019 and no objections were received following the public notification.



Neither of the reporting agencies (MoH or the Police) nor the Fire and Emergency NZ oppose this application.

The Inspector does not oppose this application reporting that:

- He held a meeting and had a general discussion with the duty manager on 6th May 2019, the applicant is aware of the responsibilities under the Act and there is no reason to believe that the applicant is not suitable to hold a licence.
- There are no concerns with goods and/or services the applicant provides at the premises.
- Police reported on the application on 13 May 2019 and the Medical Officer of Health reported on the application on 20 May 2019. Neither report opposes the application.
- He considers that the sale and supply of alcohol under these conditions is consistent with the purpose of the Act and meets the criteria as stipulated under section 131 of the Act
- The principal entrance is accessed from: Public car parking off Main Road, Katikati. The car park is shared between several retailers.
- There have been no issues raised in regard to the building code or the Resource Management Act. No issues have been brought to light from any of the agencies regarding the operation and conduct of the premises.
- He has had no major concerns with the operations of the business, nor has he received any negative feedback within the last two and half years.
- He visited the premises on 17 May 2019 at approximately 1.40 pm. All required signage was clearly displayed. The host responsibility policy was displayed. Food, low and non-alcoholic beverages were available. Alternative transportation had been considered and options were available. There was no concern for excessive noise or overcrowding. There appeared to be sufficient levels of staff to manage the premises effectively. A duty manager was present with their name prominently displayed.
- He does not oppose the design and layout of the premises. The applicant appears to have appropriate systems, staff, and training to comply with the law. The manner in which the applicant has sold, displayed, advertised or promoted alcohol has not caused concern for the reporting agencies.
- There are no negative reports from the police and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour.
- There is no visual evidence of anti-social behaviour such as discarded bottles, cans or litter to indicate the parking facilities are being used to pre-load.
- To date there have been no known noise complaints regarding the operation of the restaurant.



- There is no reason to believe that the amenity and good order of the locality would be likely to be increased, to more than a minor extent, by the effects of a refusal to renew the licence.

In summary the Inspector having enquired into the application, and based on the information provided, believes the application meets the criteria in the Act and therefore does not oppose this application.

The Decision

Subject to no new or contrary evidence being presented this application is consistent with the sale and supply of alcohol, is consistent with the Object of the Act and meets the criteria set out in Section 131 of the Act.
