Planning Report Plan Change 47 – Lots for Network Utilities, Electricity Generating Infrastructure, Reserves and Public Space

1.0 Introduction

- **1.1** The purpose of this report is to provide recommendations on submissions to Plan Change 47 Lots for Network Utilities, Electricity Generating Infrastructure, Reserves and Public Space.
- **1.2** Plan Change 47 clarifies the activity status of subdivision to create lots for network utilities, electricity generating infrastructure, reserves and public space in all zones.

2.0 Topic: Rule 12.3.2.1

2.1 Background

The proposed amendment to Rule 12.3.2.1 clarifies that subdivision to create lots for network utilities, electricity generating infrastructure, reserves and public space in all zones is a controlled activity rather than a non-complying activity.

2.2 Submission Points

2.2.1 Trustpower Limited supports the Plan Change on the grounds that the amendments increase clarity and appropriately provide for electricity generating infrastructure.

3.3 Amend Rule 12.3.2.1 as follows:

12.3.2 Lots for Network Utilities, Electricity Generating Infrastructure, Reserves and Public Open Space – All Zones

12.3.2.1 Controlled Activity Subdivision

In any zone, the minimum standards for lots shall not apply in the following cases:

As a controlled activity, in any zone, lots can be created for the purposes listed in (a) – (c) below without having to comply with the minimum *lot* sizes and other minimum standards for *lots* which would otherwise apply within the zone where the subdivision is being undertaken.

- (a) Where land is for a purpose required by a network utility operator or electricity generator.
- (b) Where land is to be set aside or vested as a reserve.
- (c) Where land is to become public open space owned by *Council*.
