THE APPLICATION

This application, submitted by the Bowentown Boating and Fishing Club Incorporated (incorporated under the Incorporated Society's Act 1908, on 7 September 1953), trading as the Bowentown Boating and Fishing Club from 26 Pio Road Bowentown; seeks a renewal of its Onsite Licence.

The general nature of the business undertaken is a CLUB LICENCE - CLASS 1 (1,520 members).

Current trading hours are:

Monday to Sunday: 10.00 am to 1.00 am the following day.

The Club's primary purpose is boating and fishing; although it has a restaurant known as BOWENTOWN BOATING AND SPORT FISHING CLUB. Its principal entrance is accessed from the main entrance at 26 Pio Road, Bowentown.

The applicant does not seek any changes to the licence.

Jocelyn Madsen is the Club's Secretary.

The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) depile to this application. Section 60 (1) (b), 60 (2), 60 (3) (c), and 61 (a) of the Act also require consideration.

REASONS FOR THE DECISION

Neither the Police nor The Medical Officer of Health, when reporting on the application, opposed the application.

The application was publicly notified in the Waihi Leader and no public objectives were received.

Based on the information provided in the application and an inspection of the premises, the inspector considers the applicant's proposal for the sale and supply of alcohol is consistent with the purpose of the Act and meets the criteria under section 131 of the Act.

The Inspector does not oppose the application reporting that:

- When conducting a site visit on 21st May 2023 and meeting Stu Curd (the Club Commodore) and the named Manager on duty, all required signage was clearly displayed. Food, low and non-alcoholic beverages were available. Free water was also available. No issues were identified with the operation of the premises in accordance with the object of the Act not any information regarding the conduct of its members.
- The applicant appears to be aware of the Club's responsibilities under the Act and there are no concerns with the applicant's suitability.
- There have been no issues raised regarding the Building Code or the Resource Management Act.
- There are no concerns with the design and layout of the premises being a boating and fishing club consisting of a club house and a restaurant open to the public. It is situated adjacent to Tauranga harbour with a boat ramp and a large gantry. The licensed area is the entire premises, including the outside parking areas and the newly extended upper floors. The licensed area is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 10 March 2023.
- The premise does not require a designation as the principle business is the sale of food.
- The duty manager of the restaurant appears aware of the rules; knowing only members and their guests can order and consume alcohol.
- Alternative contracted transportation can be made available.
- The applicant appears to have appropriate systems, staff, and training the law.

- The premises are situated on Pio Road in Bowentown are well kept, tidy and looked after by the members.
- The inspector has no concerns in respect to the location or the operations of the club affecting the local inhabitants.
- To date no complaints have been received regarding the club activities or the actions of its members. Bowentown is covered by a 24-hour liquor ban. The inspector is unaware of any concerns relating to noise, nuisance or vandalism relating to the club. There have been no negative reports from the police and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour. Therefore, there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

Reference to the Act:

Section 60 (1) (b) The applicant wishes to have an additional condition on the licence to allow an authorised visitor to invite a guest into the premises and that guest can purchase alcohol noting:

- Section 60 (2) The applicant does not hold an off-licence.
- Section 60 (3) (c) The applicant shares reciprocal rights arrangements with Waihi Beach RSA, Waihi Beach Lifesaving club and clubs affiliated with New Zealand Sport Fishing Council.
- Section 61 (a) The club secretary is Jocelyn Madsen.

There appears to be no membership concerns.

After conducting a site visit and receiving all appropriate information the Inspector reports there is nothing to suggest that the granting of this application would not achieve the object of the Act thereby does not oppose this application.

The Local Alcohol Policy stipulates the maximum hours for a Club licence are: 9.00 am to 1.00 am the following day. The hours sought are comply with the requirements of the Local Alcohol Policy, as it applies to the premises.

Thereby subject to no new or contrary evidence being presented I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

THE DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply Alcohol Act 2012 (the Act), approves an application submitted by the **Bowentown Boati**

and Sport Fishing Club for an **On-site Class 1 Licence** to supply and sell alcohol at its premise situated at 26 Pio Road, RDI Katikati, subject to the following conditions.

The Conditions:

(a) Alcohol may only be sold on the following days and during the following hours:

Monday to Sunday: Hours: 10.00 am to 1.00 am the following day.

- (b) Free drinking water must always be available to customers from the bar.
- (c) While the premises are open for the sale and supply of alcohol no BYO alcohol must be consumed on the premises.
- (d) At all times, the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available on the premises. Menus must be visible, and food should be actively promoted.
- (e) The Licensee must have available for consumption on the premises, at all time when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- (f) The Licensee must provide information, advice, and assistance about alternative forms of transport available to patrons from the licensed premises;
- (g) The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- (h) Alcohol can be sold and supplied to guests of members of clubs with which the licensee has an arrangement for reciprocal visiting rights for members.

THE APPLICATION

This is an application by **Angelin Enterprises Limited** for renewal of an **Off licence** in respect of premises situated at **15C Minden Street**, **Te Puke**, known as **Bottle Craft Te Puna**.

The general nature of the business to be undertaken is that of a Off licence - Bottle Store.

The business is a bottle store where the principal business is the sale of alcohol and meets the criteria of s.32(1)(b) of the Act where more than 85% of the annual sales revenue is earned from the sale of alcohol for consumption somewhere else.

The applicant is a limited private company incorporated on 28 July 2020 with Barinderpal Singh and Simranjit Singh being the shareholders/directors. This is the applicant's first renewal application.

The current days and hours of operation are:

Monday to Sunday

10:00am

to 10:00pm

The applicant seeks to change the existing authorised hours to a one hour earlier opening time and closing one hour earlier. The current Local Alcohol Policy stipulates maximum trading hours of 7.00 am to 9.00 pm. Therefore, the trading hours that apply to this renewal will be:

Monday to Sunday

9.00am

to

9.00pm

As the premises is a bottle store where the principal business is selling a cohol, the entire premises is designated as a Supervised Area.

The Inspector reports that the premises are a generic bottle store layout and is well kept with a tidy appearance. There are no concerns over the way that the premises has been conducted under the current existing licence.

Public Notification

The application was publicly notified in the Weekend Sun version of the Bay of Plenty Times on the 25th of November and again on the 2nd of December 2022. No objections to the application were received by the secretariat.

The Inspector has commented that the trading name of the premises was stated incorrectly in the public notification, 'Te Puna Wines and Spirits' instead of 'Bottle Craft Te Puna'. The Agent for the applicant has submitted that the discrepancy was an oversight and not deliberate. The Inspector on the other hand is of the view that the discrepancy could still have had the potential to disadvantage the public. The issue here is between real and potential disadvantage. Standing back, I am of the view that a waiver under s.208 is appropriate on this occasion as to require readvertising in my view, would be unlikely to affect the outcome of the public notification.

REASONS FOR THE DECISION

No additional information has come to light to indicate the sale or supply of alcohol has not been managed appropriately or for that matter how the applicant has displayed, advertised, or promoted alcohol.

The Inspector reports that there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

The Police have not reported on the application so pursuant to s.104(3) of the Act it can be assumed that there are no matters in opposition.

The Medical Officer of Health on the other hand did report but did so outside the 15 working days required under s.104(3) of the Act. While not opposing the application some concerns were raised over the earlier 9.00 am opening time being sought.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

DECISION

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by **Angelin Enterprises Limited** for renewal of an Offlicence in respect of premises situated at **15C Minden Street**, **Te Puna** known as **Bottle Craft Te Puna**", subject to conditions.

Conditions

The licence is subject to the conditions listed as follows:

 Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises only on the following days and hours:
