#### **THE APPLICATION**

This application received from Hair Affair Enterprises Limited seeks a new On-licence. The applicant is a private limited company, incorporated on 07 September 2023. Hardeep Singh Khosa and Jatinder Singh are directors and equal shareholders of the applicant company. This is their first venture in the industry.

The applicant purchased the business and took it over in late March 2024. The applicant intends to continue to operate in the manner of a hotel. Currently the applicant is trading under their second temporary authority (022/TAON/9416/2024), expiring on 27 December 2024.

There are two principal entrances to the premise; one accessed from Wilson Road, Waihī Beach and the other from a large carpark on the side of the premises.

The criterion for the issuing of this licence is found under section 105 of the Sale and Supply of Alcohol Act 2012 (the Act).

#### **REASONS FOR THE DECISION**

The application was publicly notified on the Western Bay of Plenty District Council website. There have been no public objections made in the prescribed time scale. However, as there was an error in the licensed hours of the public notices, with the notices stating a start time of 8:00 am instead of 9:00 am. The DLC grants a Waiver under Section 208 of the Act by acknowledging that this error appears not to significantly disadvantage the public.

The application was originally opposed the reporting agencies (MOoH and the Police) but after further discussions and changes agreed this is no longer the case as both the Police and MOoH has since withdrawn its opposed.

The Medical Officer of Health (MOH) has not since withdrawing its initial opposition reported again on this application. As per Section 103(4) of the Act the DLC can assume the MOH have no matters in opposition.

The application therefore is no longer opposed by any of the reporting agencies and no public objections received.

One of the initial concerns raised related to the Waihi Beach Hotel as it is viewed as one of highest-risk premises with a rocky history regarding compliance with the Act. However, the applicant after discussions with the Inspector has taken an active role in the operation of the premises and appeared to have a good level of support in starting this venture.

The Inspector considers the applicant to be suitable and their proposal for the sale and supply of alcohol is consistent with the Act's purpose and meets the section 105 criteria.

Both Jatinder and Hardeep have been granted manager's certificates and have continued to employ staff who worked under the previous licensee.

The Inspector considers the applicant to be suitable and their proposal for the sale and supply of alcohol is consistent with the Act's purpose and meets the section 105 criteria.

A planning and building certificate issued under 100(f) of the Act has been issued and is attached. The proposed use of the premises meets the requirements of the Resource Management Act 1991 and the Building Code.

The premises has five distinct areas: the bar area, a cocktail lounge, restaurant, event area, and accommodation facilities. The bar area includes the courtyard on the left side of the premises, this area is designated as supervised. The bar service area is on the right of the room and the manager standing in the bar has a clear view of the licensed area. However, if the bar became populated then the view to the courtyard would diminish.

The off-licence held for the premises is not currently in use, but the applicant plans to reopen this in the near future. Following some concerns raised from the Police and MOH, the applicant has agreed to only allow for off-licensed sales to occur from the bottle store area marked on the licensed area plan. The Off-Licence is sought under a separate application.

The cocktail lounge named 'The Lounge' is located directly behind the bar to the centre of the premises. This area is newly renovated and consists of a bar and has approximately six tables and chairs. This area is undesignated.

The restaurant named 'Mazzola's' is located beyond the cocktail lounge on the right-side of the premises. This is a large area has tables and chairs of various sizes and the outside deck area with tables and chairs. This area has been renovated and is undesignated. The event space is located to the left of the cocktail lounge, behind the bottle store. It is primarily used for large band and music events. A small bar is also located in this area, but it is only operational during larger events. The external accommodation is occasionally used, sometimes by staff but is also used by people attending events at the pub and performers who play at those events. The duty manager will spend the majority of their time in the bar, and it is imperative that bar staff are trained so that they can assist the duty manager in responsibly managing the sale and consumption of alcohol. The licensed area is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 09 August 2024.

The applicant has requested that the bar and bottle store be designated as supervised, this is consistent with the current licence (as per condition 8 of On-licence 022/ON/8846/2023). The applicant has requested that the rest of the premises remain undesignated, which is also in line with the existing license.

A courtesy vehicle is to be available to both pick up and drop home customers to the premises and signage with taxi information is prominently displayed.

The Inspector met and conversed with Jatinder Singh. At the time of the inspection the premises was closed therefore no customers were present however all conditions of the licence were met, and the required signage was displayed. The applicant has agreed to continue with the current set of conditions on the on-licence, including the requirement for security and a one-way door policy from 10:30 pm.

The applicant appears to have appropriate systems, staff, and training to comply with the law.

Other than food, beverages, and lodging the business also hosts events such as bands, pub quizzes, and pool competitions.

The premises is situated in a commercial zone; approximately 500 metres from the town centre and is accessed from a short driveway to a large customer carpark on the left-hand side of the property. There is a liquor ban in place which covers the entire town of Waihī Beach, meaning the consumption of alcohol (except in a licensed premises) is prohibited in a public place. There are several on, off and club licensed premises in close proximity to the Waihī Beach Hotel. Majority of these premises are located within the town centre on Wilson Road, Waihī Beach. However, the closest residential property is located approximately 150 metres away, across the road from the premises. A green open space surrounds the rear and sides of the premises. The site adjacent to the left of the premises is currently under construction, the final buildings will consist of 27 apartments and 11 retail units.

The premises is clean, presentable and in keeping with the local area. The Inspector is not aware of any concerns relating to nuisance or vandalism; however, the premises has been known to invoke noise complaints in the past under previous management. There is no visual evidence of anti-social behaviour such as discarded bottles, cans, or litter to indicate the parking facilities are being used to pre-load. Once the new apartments are completed, the applicant may need to be more mindful of noise during large events, as this could potentially lead to noise complaints.

As the premises will be licensed and the applicant proposes no changes, there is no reason to believe that the issuing of this licence will affect the amenity and good order of the locality, by more than a minor extent.

#### The Conditions to apply at all times.

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

### Monday to Sunday 9.00am to 1.00am the following day

- 2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine or is residing or lodging on the premises.
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.

- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;
- 6. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 8. The premises is designated as follows: Bar Area and bottle store Supervised.

- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
  - (i) until the close of the period of 3 years after the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

This licence continues in force until 09 December 2025 unless renewed.

#### BEFORE THE WESTERN BAY OF PLENTY DISTRICT LICENSING COMMITTEE

#### THE APPLICATION

This application, received from Hair Affair Enterprises Limited (to trade as the Waihi Beach Hotel) seeks a new Off-licence. The applicant is a private limited company, (incorporated No. 8880389 on 07 September 2023). Hardeep Singh Khosa and Jatinder Singh are directors and equal shareholders of the applicant company, this is their first venture in the industry.

This application is the result of a recent change in the premises ownership. The applicant is trading under their second Temporary Authority (022/TAOFF/9417/2024) expiring on 27 December 2024) whilst this application is processed.

The applicant who purchased the business and took over in late March 2024 intends to reopen the small bottle store situated to the right of the pub area. The applicant is therefore applying for an On-licence for a Hotel; this is being considered separate from this application.

The premise has two principal entrances, one accessed from Wilson Road, Waihī Beach and the other from a large carpark on the side of the premises.

The criterion for the issuing of this licence is found under section 105 of the Sale and Supply of Alcohol Act 2012 (the Act).

#### **REASONS FOR THE DECISION**

The application was publicly notified on the Western Bay of Plenty District Council website on the 09 August 2024. No public objections were submitted within the prescribed time.

The Police originally reported on this application on 26 July 2024, with no matters in opposition. On 09 August 2024 the Police expressed concerns with the licensing the entire premises for the Off-licence. Subsequently, an opposed report was received on 17 September 2024, outside of the 15 required working days under Section 103 (3) (b) of the Act.

Following a discussion with the Police the applicant agreed to restrict all Off-licensed sales to the bottle store area and prohibit any on-licensed sales to occur in this area. The Police sent an email on 22 November 2024, and based on these changes, the Police withdrew their opposition to the application.

The Medical Officer of Health (MOoH) initially reported on the application on 05 August 2024; that report opposed the application due to similar concerns to the Police. Following various discussions between the applicant's agent and the opposed agencies. On 14 November 2024 the applicant agreed to restrict all off-licensed sales to the bottle store area and prohibit any on-licensed sales to occur in this area. On 04 December 2024 the MOoH withdrew the report in opposition noting that, "No Off-licence sales are to be consumed in the licensed area of the Waihi Beach Hotel premises".

Therefore, the application is no longer opposed by the reporting agencies and no public objections have been received.

Initially there were some concerns raised as Waihi Beach Hotel is one of our highest-risk premises with a rocky history regarding compliance with the Act. The applicant has since taken an active role in the operation of the premises and appeared to have a good level of support in starting this venture.

Both Jatinder and Hardeep have been granted manager's certificates and have continued to employ staff who worked under the previous licensee.

Although The Inspector originally had concerns regarding the applicant's suitability (in respect to the operation of the on-licence being sought), the Inspector has since reported that the applicant has made a significant effort to mitigate these concerns and as an outcome considers the applicant to be suitable and their proposal for the sale and supply of alcohol is consistent with the Act's purpose and meets the section 105 criteria. Therefore, the applicant is now eligible to hold an off-licence under section 32 (1)(a) of the Act.

A planning and building certificate issued under 100(f) of the Act has been issued and is attached. The proposed use of the premises meets the requirements of the Resource Management Act 1991 and the building code.

The bar area including the courtyard is on the left side of the premises. This area is designated as supervised. The bar service area is on the right of the room and the manager The premises is large and has five distinct areas: the bar area, a cocktail lounge, restaurant, event area, and accommodation facilities.

The cocktail lounge named 'The Lounge' is located directly behind the bar to the centre of the premises. This area is newly renovated and consists of a bar and has approximately six tables and chairs. This area is undesignated. The restaurant named 'Mazzola's' is located beyond the cocktail lounge on the right-side of the premises. This is a large area has tables and chairs of various sizes and the outside deck area with tables and chairs. This area has been renovated and is undesignated.

The entire premises comprises two parts is licensed: one cover the tavern and bottle store areas the other section is the cocktail lounge, restaurant, event space, accommodation,

and surrounding outdoor areas. The duty manager will spend the majority of their time in the bar. An event space is located to the left of the cocktail lounge, behind the bottle store. It is primarily used for large band and music events. A small bar is also located in this area, but it is only operational during larger events.

The external accommodation is occasionally used, sometimes by staff but is also used by people attending events at the pub and performers who play at those events.

The licensed area is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 09 August 2024.

The applicant has requested that the bar and bottle store be designated as supervised, this is consistent with the current licence (as per condition 3 of Off-licence 022/OFF/8848/2023). Additionally, the applicant has requested that the rest of the premises remain undesignated, which is also in line with the existing license. The Inspector has no concerns with the planned design and layout of the premises.

When visiting the premises although at a time when the premises were closed, the inspector conversed with Jatinder Singh and reports that all conditions of the licence were met, with the required signage displayed. The applicant appeared to have appropriate systems, staff, and training to comply with the law. The applicant also outlined the plans re-open the bottle store. This will be operated at busy times with its own certified duty manager. As per condition 9 of the On-licence C.O.A qualified security personnel are on duty at the premises on Friday and Saturday evenings. The applicant has also installed a robust CCTV security system to monitor the premises.

At the time of inspection, no other goods or services were observed, other than food, beverages and lodging.

The premises being situated at 60 Wilson Road, Waihī Beach is approximately 500 metres from the town centre in a commercially zoned area. There is a liquor ban in place which covers the entire town of Waihī Beach. Accessed to the premise is from a short driveway to a large customer carpark on the left-hand side of the property. There are several on, off and club licensed premises in close proximity to the Waihī Beach Hotel. Majority of these premises are located within the town centre on Wilson Road, Waihī Beach with the closest residential property is located approximately 150 metres away. A green open space surrounds the rear and sides of the premises. The site adjacent to the left of the premises is currently under construction, the final buildings will consist of 27 apartments and 11 retail units.

The Inspector reports that the premises is clean, presentable and in keeping with the local area and that she not aware of any concerns relating to nuisance or vandalism; however, the premises has been known to invoke noise complaints in the past under previous management and reports there is no visual evidence of anti-social behaviour such as discarded bottles, cans, or litter to indicate the parking facilities are being used to preload. As the premises is licensed and the applicant proposes no changes, there is no reason to believe that issuing this licence would affect the amenity and good order of the locality, by more than a minor extent.

Standing back and considering this application, the Inspector reports there is nothing to suggest that the granting of this licence application would not achieve the object of the Act.

The applicant seeks the following days and hours: Monday to Sunday: Hours: 9:00 am to 9:00 pm. The Local Alcohol Policy stipulates the maximum hours for an Off-licence are: 7.00 am to 09.00 pm. The hours sought are thereby acceptable under the local alcohol policy.

The hours sought are within those authorised under the current Local Alcohol Policy (LAP) which stipulates maximum trading hours of 7.00 am to 9.00 pm.

The premises is a specialist wine shop with some spirits also stocked. There is a wide range of products including many that are upmarket and expensive. As the principal business is selling alcohol, the entire premises is designated as a Supervised Area.

The Inspector reports that the premises are a specialist upmarket bottle store albeit a little congested with stock but is otherwise of a tidy appearance. There are no concerns over the way that the premises has been conducted under the current existing licence.

#### **Public Notification**

The application was publicly notified on the Western Bay of Plenty website on 19 October 2024. No objections to the application were received by the secretariat within the statutory timeframe.

### REASONS FOR THE DECISION

No additional information has come to light to indicate the sale or supply of alcohol has not been managed appropriately by Mr Bartee under the previous licence, or for that matter how alcohol has been displayed, advertised, or promoted.

The Inspector reports that there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of the issue of the licence.

The Police have raised no matters in opposition.

The Medical Officer of Health has not reported on this application. Pursuant to section 103(4) of the Act the DLC can assume that the Medical Officer of Health has no matters in opposition.

The applicant is providing complimentary nibbles such as chocolate, cheese, crackers, salami, and breads for those attending the events. Free water will also be available for

onsite for consumption.

Jonathan Seton Clare, the director of the applicant company, holds a current Managers Certificate 022/Cert/9261/2024 (expiry date 10 May 2027) issued by the Western Bay of Plenty District Licensing Committee has been appointed to manage the events.

The applicant has advised that a typical customer will try up to three spirits with sample size of between 10 to 15 mL. The spirits will typically be mixed with a non-alcoholic mixer, with the finished product being approximately 60mL. The applicant would like to option for customers to try his entire range of products, which includes four Vodka's at 40% abv, one Vodka at 27% abv, and one Liqueur at 27% abv. The applicant understands that sampling all the products could put someone over the drink-driving limit. To address this, he will speak with customers beforehand and adjust accordingly.


