RESERVED DECISION OF THE COMMITTEE

Background

- 1. The township of Te Puke has a residential population of around 13,000 and there are a number of residential and commercial developments underway in the district. It is expected that the population will swell by an additional 10,000 in the coming years. Infrastructure and service providers will be required for the growing population.
- Marigold Café has been in the main street of Te Puke for many years. By all accounts it has a good reputation as a daytime café offering light meals and cabinet food.
- 3. Te Puke has recent history of public place drinking and alcohol related harm caused by street dwellers and other vulnerable persons. This has affected the town centre negatively and projects have been put in place to limit access to alcohol by these persons.

Applicants Evidence

- 4. Ravinder Singh Chahal told us that he bought Marigold Cafe in May of 2023 and in October he decided to try and extend the offering to include a dinner service with alcohol.
- 5. He has worked in restaurants for several years in Rotorua and has employed an experienced certificated manager to lead a staff of eight at Marigold Cafe. He does not plan to work in front of house himself but will be overseeing the running of the business.
- He confirmed that the business would remain a low risk, class 3 restaurant, with only table service of alcohol to patrons inside the premises.



- 7. He was questioned by the Committee and told us that his experienced manager would be in charge of training the new staff. He was aware of the issues around alcohol abuse in Te Puke and that he had had no problems so far with those that lived on the streets and in the parks.
- 8. He was aware that he could not allow intoxicated persons to be on the premises.
- 9. He was told by Kassie Ellis that they should stick to what they are currently doing i.e. a daytime alcohol free café.
- 10. His main certificated manager, Gaurav Nanda, then addressed the Committee. He said he had more than 10 years' experience in hospitality and had agreed to run the business for his friend. He plans to work the middle shift and oversee the staff as they settled into the new regime should a licence be granted.
- 11. In response to questions from the Committee, he said he already had two additional certificated managers waiting to start work. The outside tables would come inside during the afternoon and no alcohol would be permitted to be consumed outside the premises.

Evidence of the Inspector

- 12. The Report of the Inspector was affirmed as true and correct.
- 13. Inspector Turner's conclusion was that an ON Licence could be granted for this low-risk activity.

Objectors

- 14. First, we heard from Mrs. Joan Dugmore. She is a long time local resident and has serious concerns for the town due to the abuse of alcohol. She said Marigold Café is a family café and should stay that way. She said there are already 15 sellers of alcohol in the town, and they did not need anymore. She said parking is already at a premium and this proposal would make it worse.
- 15. To questions from the Committee, she agreed that if the town continued to grow as predicted then there would be a need for more facilities and shops. She said, *"The place won't cope with the influx."*



- 16. She was concerned about the existing problems with homeless people living on the street and abusing alcohol. She conceded that the proposed activity with table service only of alcohol, did alleviate some of her concerns.
- 17. Ms. Kassie Ellis is a social worker in Te Puke and the Chair of the Te Puke Community Board. However, she appeared before us as a natural person. She held serious concerns about the current effects of excessive alcohol consumption in and around Te Puke. To the operators of Marigold Café, she said "You are a great business, stay that way. Don't become part of the problem."
- 18. The third objector, Mr. Mark Simpson, was unable to appear in person to support his objection due to work commitments. His concerns were very similar to those of the first two objectors. He believed that Te Puke did not need another outlet for alcohol.

Relevant legislation

19. Section 3 of the Act states the purpose of the Act as follows:

- (1) The purpose of Parts 1 and 3 and the schedules of this Act is, for the benefit of the community as a whole, –
- (a) to put in place a new system of control over the sale and supply of alcohol, with the characteristics stated in subsection (2); and
- (b) to reform more generally the law relating to the sale, supply, and consumption of alcohol so that its effect and administration help to achieve the object of this Act.
- (2) The characteristics of the new system are that-
- (a) It is reasonable; and
- (b) Its administration helps to achieve the object of this Act.
- 20. Section 4 states the Object of the Act as follows:

(1) The object of this Act is that -

- (a) The sale, supply, and consumption of alcohol should be undertaken safely and responsibly; and
- (b) The harm caused by the excessive or inappropriate consumption of alcohol should be minimised.
- (2) For the purposes of subsection (1), the harm caused by the excessive or inappropriate consumption of alcohol includes –
- (a)Any crime, damage, death, disease, disorderly behaviour, illness, or injury, directly or indirectly caused, or directly or indirectly contributed to, by the excessive or inappropriate consumption of alcohol; and



(b)Any harm to society generally or the community, directly or indirectly caused, or directly and indirectly contributed to, by any crime, damage, death, disease, disorderly behaviour, illness, or injury of a kind described in paragraph (a).

21. Section 105 of the Act provides the criteria that the licensing committee must have regard to in deciding whether to grant a licence:

105 Criteria for issue of licences

(1) In deciding whether to issue a licence, the licensing authority or the licensing committee concerned must have regard to the following matters:

(a)the object of this Act:

(b)the suitability of the applicant:

(c)any relevant local alcohol policy:

(d)the days on which and the hours during which the applicant proposes to sell alcohol:

(e)the design and layout of any proposed premises:

(f)whether the applicant is engaged in, or proposes on the premises to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods:

(g)whether the applicant is engaged in, or proposes on the premises to engage in, the provision of services other than those directly related to the sale of alcohol, lowalcohol refreshments, non-alcoholic refreshments, and food, and if so, which services:

(h)whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence:

(i)whether (in its opinion) the amenity and good order of the locality are already so badly affected by the effects of the issue of existing licences that—

(i)they would be unlikely to be reduced further (or would be likely to be reduced further to only a minor extent) by the effects of the issue of the licence; but

(ii)it is nevertheless desirable not to issue any further licences:

(j)whether the applicant has appropriate systems, staff, and training to comply with the law:

(k)any matters dealt with in any report from the Police, an inspector, or a Medical Officer of Health made under <u>section 103</u>.

(2) The authority or committee must not take into account any prejudicial effect that the issue of the licence may have on the business conducted pursuant to any other licence.

106 Considering effects of issue or renewal of licence on amenity and good order of locality

(1) In forming for the purposes of section 105(1)(h) an opinion on whether the amenity and good order of a locality would be likely to be reduced, by more than a minor extent, by the effects of the issue of a licence, the licensing authority or a licensing committee must have regard to—

(a)the following matters (as they relate to the locality):

(i)current, and possible future, noise levels:

(ii)current, and possible future, levels of nuisance and vandalism:



(iii)the number of premises for which licences of the kind concerned are already held; and

(b)the extent to which the following purposes are compatible: (i)the purposes for which land near the premises concerned is used: (ii)the purposes for which those premises will be used if the licence is issued.

(2) In forming for the purposes of section 131(1)(b) an opinion on whether the amenity and good order of a locality would be likely to be increased, by more than a minor extent, by the effects of a refusal to renew a licence, the licensing authority or a licensing committee must have regard to the following matters (as they relate to the locality): (a)current, and possible future, noise levels:

(b)current, and possible future, levels of nuisance and vandalism.

Reasons for the decision

The Act requires that when deciding whether to grant a licence or not, the licensing committee **must have regard** to the matters contained in section 105 and 106 of the Act.

Section 105(1)(a) The Object of the Act

- 22. Section 105(1)(a) of the Act requires the licensing committee to have regard to the object of the Act and in particular that the sale, supply and consumption of alcohol should be **undertaken safely and responsibly**. Also, the harm caused by the **excessive or inappropriate use of alcohol should be minimised**.
- 23. We must also read Section 3 together with Section 4 and ensure that the administration of the Act is reasonable and benefits the community as a whole.
- 24. We come back to the Object once we have considered the other clauses of 105 & 106.

Section 105(1)(b) Suitability of the Applicant

- 25. Section 105(1)(b) says that the applicant must be a suitable entity to hold an onlicence. In this regard the suitability of the applicant is not seriously challenged by any party. Mr. Chahal appears to be a sensible and knowledgeable individual and we find him and RCMK Limited suitable to hold an ON Licence.
- 26. One of the positive features of this application is the large number of current and future staff appointments that are planned. We often have to consider applications.



with only skeleton crew proposals and inexperienced staff.

Section 105(1)(c) Relevant Local Alcohol Policy

27. In respect of section 105(1)(c) of the Act there is a relevant Local Alcohol Policy (LAP) in force and the application complies with the policy recommendations for ON Licences.

Section 105(1)(d) The days and hours of operation of the licence

- 28. The proposed maximum operating hours are **Monday to Sunday 9.00am to 10.00pm**. These days and hours are within the default national maximum trading hours for ON licences and the provisions of the Western Bay of Plenty LAP.
- 29. The hours sought are similar to the two other evening restaurants in the town.

Section 105(1)(e) The design and layout of any proposed premises

- 30. There were concerns raised about the design and layout of the premises, i.e. is the building fit for purpose. The applicant has provided a building and planning certificate that says that the proposal meets the town planning requirements and the provisions of the Building Code.
- 31. We cannot go behind these certificates. The applicant also advised that if the business is successful, he does intend to invest in new fittings for the Café.

Section 105(1)(f) Whether the applicant is engaged in or proposes on the premises to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods?

- 32. The applicant advised they will be selling a full range of meals with low and nonalcoholic beverages. The daytime café cabinet food options will still be available. They are yet to finalise their evening menu. The intimated offer of a Beer Burger and fries is what we would expect in a pub and not a class three restaurant.
- 33. There should be an extensive range of substantive meal options based on restaurant style dining.

Section 105(1)(g) Whether the applicant is engaged in or proposes on the premises to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, and food, and if so, which services ENTY DIS



- 34. No other services will be offered.
- Section 105(1)(h) whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence:
- 35. We are directed to the parameters of s.106(1) and to have regard to a series of matters (as they relate to the locality). Firstly, we consider current and possible future noise levels.
- 36. There is no evidence that this proposal will introduce additional noise into the main street environment due to the low-risk class 3 status of the restaurant.
- 37. Regarding the current, and possible future, levels of nuisance and vandalism. We know of the current situation and that of previous years. There is no evidence to suggest that this proposal would increase levels of anti-social behaviours.
- 38. We are required to take into account: "the purposes for which land near the premises concerned is used." This is the business centre of the town. There are similar licensed establishments and a pub nearby.

Section 105 (1)(i) whether (in its opinion) the amenity and good order of the locality are already so badly affected by the effects of the issue of existing licences that— (i) they would be unlikely to be reduced further (or would be likely to be reduced further to only a minor extent) by the effects of the issue of the licence; but (ii)<u>it is nevertheless desirable not to issue any further licences</u>:

- 39. This section required careful consideration. As we know all alcohol comes from licensed premises. Some is consumed on premises; some is taken away to be consumed elsewhere. Some is consumed in the nearby streets and parks and other public spaces.
- 40. We believe the on-licensed premises have to accept their share of the cost of alcohol related harm, but we also put responsibility at the feet of off-licensed premises and those that choose to drink in public places in breach of the Alcohol Ban and/or go on to act in a disorderly manner and/or commit offences.
- 41. It is with this complex background that we have formed our opinion as to whether the amenity and good order of the area will be reduced by more than a minor extent and whether it is desirable, or not, to grant another alcohol licence in the town.



Section 105(1)(j) Whether the applicant has appropriate systems, staff, and training to comply with the law.


42. As we have stated elsewhere it was refreshing to see an application with adequate staffing levels already in place and an assurance to employ more if required. Mr. Chahal also has the luxury of having a 10-year veteran of the NZ hospitality scene heading his staff for training purposes and supervision.

Section 105(1)(k) Any matters dealt with in any report of the Police, an Inspector and the Medical Officer of Health under Section 129

43. The Police and the Medical Officer of Health did not report with any matters in opposition. We can only assume they have no concerns about this proposal. The Inspector has reported unopposed and advises that the application is capable of being granted.

DISCUSSION & REASONS FOR THE DECISION

- 44. The accepted course on how to approach our task comes from the decision of the High Court in **Otara-Papatoetoe Local Board v Joban Enterprises Ltd [2102] HCNZ 1406**¹. Applying the criteria used in that case we are expected to consider: (a) The relevant criteria in s.105 & 106; (b) Any reports presented by the Police, Medical Officer of Health and Alcohol Licensing Inspector following their respective inquiries into the application; and (c) any objections filed in accordance with the statutory requirements.
- 45. Having considered all this information (including the evidence for the applicant), we are required to stand back and determine whether the application should be granted (whether on conditions or not) or refused. This step requires us to form a view on whether there is evidence to suggest that granting the application would be contrary to the Object and the Purpose of the Act.
- 46. The application for a licence is a process not an event. On one hand we have the known issues around drinking in public spaces and the resultant harms and disorder. On the other hand, we have a businessman wanting to expand his business and offer a low risk dining and drinking opportunity for the township.
- 47. While acknowledging that there are alcohol related problems within the Te Puke area, it is our view that as this is a low risk class 3 restaurant licence that is being sought, the





amenity and good order of the area is unlikely to be reduced by more than a minor extent.

48. After standing back and evaluating the evidence that has been placed before us, we find that the current amenity and good order of the locality is not so badly affected by the existing licensed premises that we should not grant another.

THE DECISION

- 49. The District Licensing Committee has decided to grant the application for a low-risk Class 3 restaurant style ON Licence.
- 50. The licensed area will be as defined in the plan submitted excluding the outdoor area.
- 51. The licence is granted for 12 months, and the conditions can be reviewed if a renewal is sought. The ball is firmly in Mr Chahal's court to make this regime work and be in a position to show that he has sold, and supplied alcohol safely and responsibly in compliance with the conditions of the licence, and still has the support of the community.
- 52. We also clearly remind the applicant that the Committee can quickly rehear any matter it has determined at any time that it thinks fit.
- 53. To the objectors we thank them for their commitment to their town and we agree that the excessive and inappropriate consumption of alcohol and the resultant alcohol related harm must be minimised.
- 54. If operated correctly we do not believe this business will become part of the problem. If anything, it might encourage the moderate consumption of alcohol in a family friendly setting with good food, coffee, non-alcoholic refreshments along with alcohol.

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012, <u>grants</u> an application by RCMK Limited for an ON Licence in respect of premises situated at 93 Jellicoe Street, Te Puke known as " Marigold Cafe", subject to conditions.

When it issues the following conditions are to apply to this Class 3 restaurant style ON Licence:



1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

Interior- Monday to Sunday 9.00am to 10.00pm;

- 2. No alcohol is to be sold or supplied on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;
- 4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- 5. Food must be available for consumption on the premises at all times when the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted;
- A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises;

The licence is granted for 12 months from the date of issue.

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **RCMK LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **93 JELLICOE STREET, TE PUKE** and known as **MARIGOLD CAFE**, to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

Interior- Monday to Sunday 9.00am to 10.00pm;

- 2. No alcohol is to be sold or supplied on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is on the premises to dine;
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;
- 4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- 5. Food must be available for consumption on the premises at all times when the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a simitar range and standard. Menus must be visible, and food should be actively promoted;
- 6. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 7. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 8. The Licensee must display:

a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;

b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises;

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either-
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either-
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

This licence continues in force until 04 June 2025 unless renewed.

RESERVED DECISION OF THE COMMITTEE

Introduction

- By an application received on the 5th of October 2023, Graduate Trading Limited (GTL) applied for the renewal of an off-licence in respect of premises situated at 74-76 Main Road, Katikati known as Bottle-O Katikati."
- 2. The current licensed days and hours are **Monday to Sunday 8.00am to 9.00pm** in line with the recently refreshed Western Bay of Plenty Local Alcohol Policy (LAP). These hours are also within the default national maximum trading hours for off licences.
- 3. The application was duly advertised and was reported on by the agencies. The delegated officer for the Medical Officer of Health opposed the renewal on the grounds that selling single serves in a "high deprivation area" would not help achieve the Object of the Act.
- 4. The Inspector does not oppose the renewal, nor does she support the imposition of additional discretionary conditions.
- 5. The Police do not oppose the renewal.
- 6. The application was set down for a formal hearing pursuant to Section 134 and the Committee needed to hear the arguments around single sales.

Applicant's Evidence

- 7. Mr. Robert Davies, counsel for GTL, provided us with his usual helpful opening in which he referred us to relevant case law and also to the fact that his client had a single sales condition imposed by the DLC on one of their other stores and have voluntarily included it in their business practices at couple of their other stores.
- 8. He said that due to the demographics of their customer base in Katikati they do not believe a single sale condition is warranted. They do not dispute the raw data provided by James Scarfe, the data analyst, but do question its relevance to this application.
- 9. Jaskamal (Sunny) Singh spoke to us on behalf of the company. He told us that he and his extended family own and operate 8 licensed premises in Western Bay of Plenty and Tauranga.
- 10. He told us about their staffing and training programmes and their place in the Katikati community. The business is situated in the main street of Katikati and they are happy to be situated next door to the Police Station and are fully aware of the 24/7 Alcohol ban in Katikati township.



- 11. They were surprised that the MOoH has raised the issue of suitability. They have never had a compliance issue at the store, and he believed they had good systems and training at the store and around the sale and supply of alcohol.
- 12. He said a ban on the sale of single high strength beers under 500 ml was not necessary. They did not have 'at risk' clientele trying to buy those products.
- 13. They do make single sales of Diesel and Woodstock RTDs to a small number of customers who just want to purchase a couple of cold drinks to take home.
- 14. He was asked about local social issues, and he said that more than 90% of their customers were local people and not many young people tried to purchase alcohol. He said the clientele was very different from the Mount Maunganui store where customers are mainly young people.
- 15. In regard to intoxication, he said they turn away about 1-2 persons a week whom they have deemed to be intoxicated and therefore unable to be lawfully served.
- 16. They did not have a problem with customers opening their purchases and drinking them in the car park or on the street to their knowledge.
- 17. He had not seen people drinking in the park and that Katikati was their 'best' store as far as being easy to manage.

Police Evidence

- 18. We spoke briefly with Sergeant Dan Roser who told us that the Bottle-O Katikati was not a problem store for the Police. He said there were 2-3 'old lags' who frequent the township, but they did not come to notice in any significant way.
- 19. He personally vetted the application for renewal and saw no reason to oppose or seek any additional discretionary conditions.
- 20. He agreed with the concept that the DLC had to be satisfied that there should be a purpose and a reason for discretionary conditions to be added to a licence.

Inspectors Evidence

- 21. Ms. Micaela Turner is the Alcohol Licensing Inspector for Western Bay of Plenty. She confirmed her report was accurate and up to date.
- 22. The Inspector confirmed her non-opposition and that she saw no need for any additional discretionary conditions to be added to the licence.



Medical Officer of Health's Evidence

- 23. Ms. Dawn Meertens, called public health analyst, James Scarfe, to provide the DLC with an insight into the population demographics of the Katikati community.
- 24. Mr. Scarfe told us that Katikati had an elevated rate of hospital admissions wholly attributable to alcohol. He said the Bay of Plenty DHB area, as a whole, had a higher rate of hazardous drinking compared to the rest of New Zealand.
- 25. He was unable to link those factors, in other than general terms, to Katikati, or to the provision of alcohol from this store, let alone the contribution potentially made by the provision of single sales of alcoholic products.
- 26. We asked him about the presence and occupancy of any emergency housing in the area. He said the only evidence he had was that there were two facilities that were drawing payments from the Government agencies in 2023. He was unable to provide any current statistics on the numbers of people in emergency housing nearby.
- 27. He also confirmed his statistics were based on the 2018 census material that is now 6 years old. He agreed that current statistics could show a better or worse scenario.
- 28. Ms. Meertens then spoke on her opposition to the renewal and argued that a discretionary condition banning "cheap high strength single vessels of alcohol 500ml and under, excluding craft beers, and low alcohol beverages" would be beneficial to the amenity and good order of the area.
- 29. She had no direct evidence to show that an increase in the amenity and good order of the area, could be a realistic outcome of the measure.
- 30. In closing Ms. Meertens encouraged the Committee to adopt the recent Supreme Court dicta in that we should read Section 3 and 4 together and that our decisions should benefit the community as a whole.
- 31. We are also acutely aware that the imposition of discretionary conditions need to be reasonable and a proportionate response to any risk that should be abated.

Relevant legislation

- 32. Section 3 of the Sale and Supply of Alcohol Act 2012 ("the Act") states the purpose of the Act as follows:
 - (1) The purpose of Parts 1 and 3 and the schedules of this Act is, for the benefit of the community as a whole, –



- (a) to put in place a new system of control over the sale and supply of alcohol, with the characteristics stated in subsection (2); and
- (b) to reform more generally the law relating to the sale, supply, and consumption of alcohol so that its effect and administration help to achieve the object of this Act.
- (2) The characteristics of the new system are that-
 - (a) It is reasonable; and
 - (b) Its administration helps to achieve the object of this Act.
- 33. Section 4 states the object of the Act as follows:
 - (1) The object of this Act is that
 - (a) The sale, supply, and consumption of alcohol should be undertaken safely and responsibly; and
 - (b) The harm caused by the excessive or inappropriate consumption of alcohol should be minimised.
 - (2) For the purposes of subsection (1), the harm caused by the excessive or inappropriate consumption of alcohol includes
 - (a) Any crime, damage, death, disease, disorderly behaviour, illness, or injury, directly or indirectly caused, or directly or indirectly contributed to, by the excessive or inappropriate consumption of alcohol; and
 - (b) Any harm to society generally or the community, directly or indirectly caused, or directly and indirectly contributed to, by any crime, damage, death, disease, disorderly behaviour, illness, or injury of a kind described in paragraph (a).
- 34. Sections 131 of the Act provides the criteria that the licensing committee must have regard to in deciding whether to approve a renewal of the licence:
 - 131 Criteria for renewal
 - (1)In deciding whether to renew a licence, the licensing authority or the licensing committee concerned must have regard to the following matters:
 - (a)the matters set out in paragraphs (a) to (g), (j), and (k) of section 105(1):
 - (b)whether (in its opinion) the amenity and good order of the locality would be likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence:
 - (c)any matters dealt with in any report from the Police, an inspector, or a Medical Officer of Health made by virtue of section 129:
 - (d)the manner in which the applicant has sold (or, as the case may be, sold and supplied), displayed, advertised, or promoted alcohol.
- 35. The Act requires that when deciding whether to renew a licence, or not, the licensing committee must have regard to the matters contained in section 131 of the Act. We now consider them in greater depth.

Section 105(1)(a) The Object of the Act

36. The section requires the licensing committee must have regard to the object of the Act and in particular that the sale, supply and consumption of alcohol should be undertaken safely and responsibly <u>and</u> that the harm caused by the excessive or inappropriate consumption of alcohol should be minimised.



- 37. The evidence was that the applicant was well aware of its responsibilities and had been selling and supplying alcohol in a safe and responsible manner.
- 38. An example of that professionalism was the evidence that the applicants had imposed single sale restrictions voluntarily at some of their other stores.
- 39. As we have often said, the operators of off-licensed premises can do little to influence the moderate and appropriate consumption of alcohol as consumption occurs away from the premises.
- 40. We will return to the **Object and the Purpose of the Act** once we have discussed the other relevant criteria.

Section 105(1)(b) Suitability of the Applicant

41. The applicant must be a suitable entity to hold an Off-licence. No compelling evidence was presented to the Committee to the contrary.

Section 105(1)(c) Relevant Local Alcohol Policy

42. The application complies with the provisions of the recently refreshed and operative Western Bay of Plenty LAP.

Section 105(1)(d) The days and hours of operation of the licence

43. The days and hours of the current licence are within the default national maximum trading hours for off-licensed premises.

Section 105(1)(e) The design and layout of any proposed premises

44. The Committee is aware of the design and layout of the premises. It is unremarkable and there are no overt displays of single sale items in the store.

Section 105(1)(f) Whether the applicant is engaged in or proposes on the premises to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods.

45. No goods other than alcohol, low-alcohol beverages, non-alcoholic refreshments, snack items and tobacco products are sold on the premises.

Section 105(1)(g) Whether the applicant is engaged in or proposes on the premises to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, and food, and if so, which services.



46. No other services are offered.

Section 105(1)(j) Whether the applicant has appropriate systems, staff, and training to comply with the law.

- 47. The applicant advises that there are several staff with manager's certificates attached to the business and that they do hold regular training sessions.
- 48. There was no challenge made in relation to the systems, staff and training at these premises.

Section 105(1)(k) Any matters dealt with in any report of the Police, an Inspector and the Medical Officer of Health under Section 129

- 49. The Police have not opposed the renewal. The Medical Officer of Health opposed the renewal due to the potential harm arising from the single sales of high strength beers.
- 50. We discuss the issue of single sales and conditional oppositions further later in this decision.

(b)whether (in its opinion) the amenity and good order of the locality would be likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence:

- 51. No evidence has been adduced to show that this premises is adversely affecting the amenity and good order of the locality. The statistical data provided does show an elevated rate of hospital admissions but as Mr. Scarfe conceded these are mainly due to admissions for conditions wholly caused by alcohol such as cirrhosis of the liver and similar afflictions.
- 52. There was no evidence of homeless street dwellers, or other vulnerable persons, begging or stealing coins for a quick single vessel fix from the bottle store.

(d)the manner in which the applicant has sold (or, as the case may be, sold and supplied), displayed, advertised, or promoted alcohol.

53. We are satisfied that the applicant has not been overtly displaying or advertising alcohol products and prices. The Singhs told us they do not overtly advertise the single sales of RTDs and only make them available to their regular customers who only purchase a couple to take home 3-4 times a week.

Reasons for the Decision

54. Single sales have become a vexing issue for DLCs and the hospitality industry generally.



- 55. On the one hand it could be said that it is socially responsible to allow a customer to buy a single beer or a RTD if that is their wish.
- 56. On the other hand, some retailers have exploited the opportunity and deliberately 'broken' boxes of product so they can make single sales for at low as \$1.00 per bottle or can.
- 57. This is colloquially known as 'pocket money liquor.' Situations have arisen where street dwellers and beggars can beg, borrow or steal a few coins and can then repeatedly return to the bottle store and access more and more alcohol as the day goes on.
- 58. The immediate amenity and good order of the area is often reduced, offences are committed, and the Police end up having to deal with intoxicated persons and disorderly behaviour.
- 59. So how do we find the happy balance between the rights of the responsible purchaser and the need to deter the problematic singles sales that can, and do, occur in some communities?
- 60. The regulatory agencies have been recommending, and DLCs have been imposing a variety of restrictive conditions <u>when circumstances support such impositions</u>, and we have done so on a number of occasions.
- 61. We also believe that they should not be imposed arbitrarily and should be site specific.
- 62. As Gendall J so aptly stated in <u>J & G Vaudrey Limited CIV-2015-409-000098</u> [2015] NZHC 2749¹

At [14] In particular I have found:

(a) The role of the District Licensing Committee and the Authority (the relevant body) upon receipt of an application for licensing or re-licensing is an evaluative one, **requiring the decision maker to make a merits-based determination of the application**.

(c)... (d)...

(e) There is no ability under ss 112–114 of the Act to impose general conditions (but that power is to be found in s 117).

(f)....

(g) The relevant body has a discretion to impose any further conditions which are reasonable and that are "not inconsistent" with the Act. In deciding whether to impose such conditions, the relevant considerations are these:

The Common Seal of

¹ J & G Vaudrey Limited CIV-2015-409-000098 [2015] NZHC 2749

(i) <u>the relevant body must have identified a risk which it seeks to abate, or a</u> <u>benefit which it seeks to secure</u>.

(ii) that risk or benefit must be consistent with the purpose and object of the Act, and not inconsistent with the Act in its entirety.

(iii) the relevant body must direct itself as to all relevant circumstances.

(iv) it must then weigh the risk to be abated, or benefit to be secured, against the relevant circumstances as identified;

(v) the condition must be a proportionate response;

(b) ...

(vi) an absolute prohibition would not ordinarily be reasonable, nor a condition which secured a benefit or abated a disbenefit only marginally; equally, a condition may not be absurd, ridiculous, patently unjustifiable, extreme or excessive; and

(vii) Ultimately whether a condition is reasonable will depend on an objective assessment of whether there is a rational and proportionate connection between the identified risk or benefit, when weighed against all relevant considerations. (<u>underlined text our emphasis</u>)

- 63. It is not the role of the MOoH to try to impose a raft of generic conditions on every off licensed premises that come before them for enquiry and reporting.
- 64. It is the role of the DLC, and the DLC alone, to decide what is appropriate, or not, for a particular premises. We do encourage the agencies to present their views and recommendations but when they do, we expect to see evidence relating to a risk to be abated or a benefit to be secured.
- 65. Unfortunately, a number of appeals have gone to ARLA and been upheld, rejected and/or modified to a point where now some agencies are pushing for mandatory inclusion of conditions around single sales as they have been "approved by ARLA."
- 66. This is **not the case** as often the conditions have been consented to by the applicant, and may, or may not, have been appropriate for that location and merely rolled over by ARLA <u>without being tested as to their appropriateness</u>, or not.
- 67. While there is merit in having such conditions as part of Local Alcohol Policies and being consistent across the district, we believe that <u>all discretionary conditions</u> must be necessary and site specific. Applicants are entitled to a level playing field if, and when, the playing field is level!



- 68. However, if we were to have a bottle store in an Alcohol Ban Area, with a high deprivation vulnerable population nearby and evidence of 'at risk' persons seeking pocket money alcohol AND operators catering to those demands by breaking boxes and offering \$1, \$2, or \$3 beers and RTDs, discretionary conditions around single sales will very likely be appropriate and will be imposed either by consent or via the hearing process.
- 69. In this case we have a bottle store operating in a 24/7 Alcohol Ban Area but no hard evidence of localised alcohol abuse or social issues. The evidence suggest single sales are a very minor proportion of sales and no additional intervention is necessary.
- 70. For the reasons above, the Committee has determined that renewal should be granted with no change to the existing conditions.

The Decision

The Licence will be renewed for three (3) years from the expiry of the current licence on the following conditions:

- 1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours: **Monday to Sunday 8.00am to 9.00pm**;
- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. The whole of the premises is designated as a Supervised Area;
- 5. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- **11.** The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;



- b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale and supply of alcohol.
- c. A copy of the licence is to be attached to the inside of the premises so as to be easily read by people entering each principal entrance.

THE APPLICATION

This is an application by **Amatis Limited** for renewal of an **Off licence** in respect of premises situated at **270 Matahui Road, Aongatete, Katikati,** known as **Matahui Distillery.**

The general nature of the business is that of a boutique manufacturer of specialist spirits and sells them from the premises, that is via a 'cellar door'. The premises is of the type that comply with s.32(1)(d) of the Act where the principal business carried out is the manufacture of alcohol. No endorsement under s.40 (remote sale) of the Act has been sought.

The applicant is a limited private company incorporated on 25 August 2016. Paul Horak is the sole director and a shareholder of the applicant company. Two other named shareholders are Christopher Railton and Angela Howard. This is the applicant's first renewal application.

Public Notification

The application was publicly notified in the Katikati Advertiser on 18 April 2024. No objections to the application were received by the secretariat. The Inspector has noted that the notice was published two days outside of the required time frame and recommends that a waiver be granted pursuant to s.208 of the Act as the error was not deliberate. I agree, the error is a small one and would have been unlikely to disadvantage the public generally.

REASONS FOR THE DECISION

The application is complete and contains all the required supporting documents required under section 127 of the Act.



The Police and the Medical Officer of health have reported on the application and offer no matters in opposition.

Paul Horak is the holder of a general manager's certificate.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act and that the applicant is carrying out the business as a manufacturer of alcohol with sales being carried out via a 'cellar door'.

DECISION

The District Licensing Committee Chair, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** the application by **Amatis Limited** for renewal of an Off-licence in respect of premises situated at **270 Matahui Road, Aongatete, Katikati** known as **"Matahui Distellery**", subject to conditions.

Conditions

The licence is subject to the conditions listed as follows:

1. Alcohol, subject to condition 3, may be sold on and delivered from the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday 7:00 am to 9:00 pm

- b. At the principal entrance to the premises, so as to be easily read by people outside the premises, a sign stating the ordinary hours of business during which the premises will be open for the sale of alcohol;

The premises are a small sized restaurant with no specific bar area and consist of both internal and external seating areas. Alcohol is stored in a fridge to the left of the service counter.

No changes being sought from the existing licence are sought. There have been no matters raised in regard to the Resource Management Act. The criteria found at section 131 of the Sale and Supply of Alcohol Act 2012 (the Act) applies to this application.

REASONS FOR THE DECISION

The renewal application was publicly notified in the Katikati Advertiser on 18 April 2024. No objections have been received by the Secretariat within the statutory time trame. The Inspector reports that both the Public Notice and the site notice stated an incorrect licensing opening time of 8.00 am when it should have been 9.00 am and recommends that a waiver be granted pursuant to s.208 of the Act. Given that the incorrect time was greater than the existing authorised opening time, in my view there has been no disadvantage to the public. The waiver is therefore granted.

The principal entrance is accessed from the customer carpark off Wharawhara Road in Katikati.

The Inspector has reported that there are no concerns regarding the operation of the premises and no concerns have been reported from the agencies regarding the conduct of the sale, supply, and consumption of alcohol on the premises.

Neither the Police nor the Medical Officer of Health have raised no matters in opposition to the application.

I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act. Accordingly, the application will be determined on the papers.
