## **THE APPLICATION**

This application, submitted by **THE ADDRESS INDIAN KITCHEN LIMITED** (a New Zealand Incorporated private company No. 7325516 14/03/2019); seeks a renewal of its **ON LICENCE** in respect of premises situated at **SHOP 4, 168 ŌMOKOROA ROAD, ŌMOKOROA,** now trading as **MAD MIRCHI.** Its principal entrance is accessed from the footpath off the shared carpark at 168 Ōmokoroa Road, Ōmokoroa.

The premises, a small size Indian restaurant, is situated in the commercial shopping centre located at 168 Ōmokoroa Road, Ōmokoroa. The general nature of the business to be undertaken is that of a On Licence - Class 3 Restaurant.

The business has been trading with an On-licence since 29 April 2019. This is the applicant's fourth on-licence application for this premises. Gurpreet Singh is the sole director and Jasvir Kaur is the sole shareholder of the applicant company. In June 2023, when the previous directors (Kuldeep Singh and Gagandeep Kaur) resigned from the company; Jasvir Kaur and Gurpreet Singh were appointed to manage the business.

The applicant does not seek any changes to the licence other than to register its new trading name.

It is noted that the restaurant is currently closed, As the applicant plans to sell the business, the applicant would like to proceed with this application so that the new owner has the ability sell alcohol under a temporary authority, if desired. The applicant has sought opening hours to be Monday to Sunday: 10:00 am to 11:00 pm.

The criterion for the renewal of this licence is found under section 131 of the Sale and Supply of Alcohol Act 2012 (the Act).

#### **REASONS FOR THE DECISION**

The application was publicly notified in the Lizard News in June 2024 and no objection was received with the specified time.

The Police have not reported on the application. As per Section 103(4) of the Act the DLC assume the Police have no matters in opposition.

When the Medical Officer of Health reported on the application no matters in opposition to the application were raised but the report did recommend a minimum of three types of Low alcohol and 0% alcohol beers/ciders/ RTDs be made available and recommends having a minimum of three duty managers.

The Inspector after meeting with the applicant considers Parwinder Singh, a certified manager, to be aware of his responsibilities and of the requirements under the Act. In addition, the proposal for the sale and supply of alcohol is consistent with the Act's purpose and meets the section 131 criteria. Inspector also reports:

There have been no issues raised regarding the Building Code or the Resource Management Act.

The premises matches the floor plan provided with the application and the Inspector has no concerns with the design and layout of the premises. The applicant has requested a restricted designation for the kitchen and bar area and a supervised designation fort the front-of-house (dinning) area. This premises does not require a designation as the principal business is providing meals. The applicant has requested the entire internal area and small outside strip in front of the premises to be included in the licensed area. The licensed area is defined on the plan date stamped as received by Western Bay of Plenty District Council on 16 May 2024.

When visiting the premises the Inspector met and conversed with Parwinder Singh – the duty manager, the premises was closed so no customers were present. The minor and intoxication signage was displayed, but there was no duty manager signage. Food, water, and non-alcoholic beverages were available; however, the low-alcoholic option had run out, Parwinder was advised to buy more before opening. Free water was also available. The manager's register was unable to be produced at the inspection. There were no taxi cards available, Parwinder noted that new cards had been ordered. Other alternative transportation options were discussed. Although notification of the intent to renew the licence was published the newspaper, the public notice was not displayed onsite.

All these concerns were notified to the licensee who swiftly addressed the areas of non-compliance, sending through an updated manager's register and explanation of the steps taken to address each area of concern.

With the changes made, the applicant now appears to have appropriate systems, staff, and training to comply with the law.

If the applicant reopens the restaurant, the Inspector and the MOoH recommends they consider hiring more certified staff or training existing employees to obtain a manager's certificate.

No other goods or services were observed, other than food and beverages.

There is no liquor ban in place in Ōmokoroa. The restaurant is nestled between a gym and a bottle store. Some of the other shops situated in the shopping area includes an onlicensed restaurant, pizza shop, barber, coffee shop and medical centre. Behind the store is a separate block of shops which includes the Fresh Choice (holds an off-licence), a sushi shop, laundromat, pizza shop, and on-licensed Indian restaurant. A new shopping centre has recently opened approximately 100 metres from the premise. This centre includes many unlicensed stores as well as a licensed restaurant, café, and a bottle store.

The premises is clean, presentable and in keeping with the surrounding local area with no visual evidence of anti-social behaviour such as discarded bottles, cans or litter to indicate the outside area is being used to pre-load and there is no information to suggest the premises is associated with any criminal behaviour. Therefore, there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence

The surrounding area outside the store is zoned as residential. No complaints or concerns from members of the community regarding this proposed application. The Inspector is not aware of any concerns relating to noise, nuisance or vandalism relating to licensed premises in the area.

The Inspector, after carrying our due diligence on the application and applicant reports there is nothing to suggest that the granting of this application would not achieve the object of the Act.

The Local Alcohol Policy stipulates the maximum hours for an On-licence are: 9.00 am to 1.00 am the following day. The hours sought are within the hours permitted under the local alcohol policy.

## **THE DECISION**

The District Licensing Committee Chairperson, acting pursuant to the Sale and Supply of Alcohol Act 2012, thereby grants a renewal of a Class 3 On Licence to **THE ADDRESS INDIAN KITCHEN LIMITED**, now trading as **MAD MIRCHI**, in respect of premises situated at **SHOP 4**, **168 ŌMOKOROA ROAD**, **ŌMOKOROA**, subject to the following conditions.

The Conditions:

 Alcohol may only be sold and consumed on the premises on the following days and during the following hours:

Monday to Sunday: Hours: 10.00 am to 11:00 pm

- 2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a person who is present on the premises to dine.
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages (≤2.5% abv).
- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
- 6. A properly appointed certificated or acting or temporary manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.

## **THE APPLICATION**

This application, submitted by **TE PUNA RUGBY FOOTBALL CLUB INCORPORATED** (a Society, incorporated on 31 October 1975), seeks a renewed **CLUB LICENCE** in respect of premises situated at **MARAMATANGA PARK**, **TE PUNA**, known As **TE PUNA RUGBY FOOTBALL CLUB**. The principal entrance to the Club is accessed from a large carpark located at Maramatanga Park, 17 Tangitu Road, Te Puna.

The general nature of the business to be undertaken is that of a CLUB LICENCE - CLASS 2. The Club's current Licence 022/RENCL/8271/2021 has an 25<sup>th</sup> July 2024 expiry date. It does not hold an off-licence.

The Council's records show this is the twelfth application since 1991.

The applicant has sought a change to extend the current licensed hours seeking the following days and hours:

• Monday to Thursday:

Hours: 5:00 pm to 11:00 pm.

• Friday:

Hours: 5:00 pm to 12:00 am midnight.

Saturday:

Hours: 1:00 pm to 1:00 am the following day.

The

• Sunday:

Hours: 1:00pm to 10:00pm.

The club secretary is Billie-Jo Simmons.

The club does also offer other sports such as netball and cricket.

The criterion for the renewal of this licence is found under section 131 of the Sale and Supply of Alcohol Act 2012 (the Act).

## **REASONS FOR THE DECISION**

The Police did not report on this application. As per Section 103(4) of the Act the DLC can assume the Police have no matters in opposition.

The Medical Officer of Health reported on the application on 05 July 2024. That report did not oppose the application but recommended a minimum of three types of Low alcohol and 0% alcohol beers/ciders/ RTDs be made available and recommended having a minimum of three duty managers.

No public objections were received.

The Inspector as part of her due diligence process held a general discussion with Gabrielle Rolleston (a certified manager appointed to the Club) during an inspection and reports the certificated manager appears to have an excellent understanding of the Club's responsibilities under the Act.

To date, the Inspector has not received any concerning information regarding the operation of the premises, nor has any information has come to light regarding the conduct of its members thereby applicant appears suitable and their proposal for the sale and supply of alcohol is consistent with the Act's purpose and meets the section 131 criteria.

It appears that the sale or supply of alcohol has been appropriately managed.

When the application was publicly notified on the Western Bay of Plenty District Council website 1st August to 5 September 2024 no objections were received. However, due to an administrative error the public notice was published outside of the legislative timeframe. As we understand this error has not significantly disadvantage the public, **the DLC grants a Waiver under Section 208 of the Act.** 

There have been no issues raised regarding the Building Code or the Resource Management Act.

The Inspector does not have any concerns or subject changes to the layout of the facilities or Licensed area: The licensed area is more precisely defined on the plan date stamped as received by Western Bay of Plenty District Council on 26 June 2024.

The applicant has requested a supervised designation from 7:30pm for the entrance, hallway, bar area and balcony area. As the principal purpose of the club is sports, it is not necessary to have a designated area. It is appreciated the club's initiative and agree with it in respect to it becoming a 'club rule'; however, as it may lead to some compliance issues if designated on the licence as that anyone under 18 would be unable to purchase a non-alcoholic beverage after 7:30 pm unless accompanied by a parent or legal guardian, the DLC view this as unnecessary at this time.

The Inspector reports all required signage was prominently displayed in the designated areas. Low and non-alcoholic beverages and free water was also available when you visited the premises. Alternative transportation had been considered and options were discussed as was food options.

The applicant appears to have appropriate systems, staff, and training to comply with the law.

Seal

There is no liquor ban in place in Te Puna. The Club is situated in a rural -residential area. Several houses are located within approximately 300 meters from the club. No complaints have been received from the local residents regarding how the club's operations. It is noted that Tutereinga Marae is situated at the end of Tangitu Road. The majority of the surrounding land consists of interspersed rural housing, kiwifruit orchards and fields of maize.

No concerns relating to noise, nuisance or vandalism or to the licensed premises have been raised and there is no visual evidence of anti-social behaviour such as discarded bottles, cans or litter to indicate the parking facilities are being used to pre-load. Similarly, there have not been any negative reports from the police regarding the operations of the Club and no visual signs of crime in the local vicinity. There is no information to suggest the premises are associated with criminal behaviour.

Overall, the premises have been described as clean, presentable and in keeping with the local area and there appears no concerns with where the Club is situated or for that matter the operations of the Club affecting the residents living in the area. Therefore, there is no reason to believe the amenity and good order of the locality would likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

As per Section 60 (1) (b) the applicant already has this as a condition of their clublicence (condition 3).

Section 60 (2) The applicant does not hold an off-licence.

**Section 60 (3) (c)** The applicant shares reciprocal rights arrangements with many other sports Clubs. A list was provided with the application. Thereby there is no concerns raised regarding the membership.

The Inspector after carrying out due diligence considering this application, there is nothing to suggest that the granting of this application would not achieve the object of the Act.

The Local Alcohol Policy stipulates the maximum hours for a Club-licence are: 9.00 am to 1.00 am the following day. The hours sought are within the hours permitted under the local alcohol policy. The applicant has requested to amend the licensed hours to start one hour earlier on Sundays, the DLC do not oppose this change.

#### THE DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **APPROVES** an application by **TE PUNA RUGBY FOOTBALL CLUB INCORPORATED** a renewal of a **CLASS 2 CLUB LICENCE** in respect of premises situated at Maramatanga Park, 17 Tangitu Road, Te Puna; subject to the following conditions.

The application was publicly notified in the Katikati Advertiser on the 25th of July 2024 and no objections were received from members of the public.

Hours: 6.00p.m. to 1.00a.m. the following day.

Saturday & Sunday:

Hours: 11.00a.m. to 1.00a.m. the following day.

## No changes are sought.

A good list of substantive food options and low and non-alcoholic beverages are available at all times when the premises is open for the sale and supply of alcohol.

Neither the Police nor the Medical Officer of Health has raised any matters in opposition.

#### **REASONS FOR THE DECISION**

The principal activity is squash club and the inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent and that the Club has sound host responsibility practices.

We have not imposed a condition requiring a certificated manager to be on duty whenever the bar is open. However, we would expect a certificated Manager to be on duty at least on the busy days and for tournaments.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.


